A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, APPROVING INTERGOVERNMENTAL AGREEMENTS WITH LITTLETON PUBLIC SCHOOLS, SOUTH SUBURBAN PARKS AND RECREATION DISTRICT AND A LETTER AGREEMENT WITH URBAN DRAINAGE & FLOOD CONTROL DISTRICT CONCERNING INCLUSION OF AGRICULTURAL LAND INTO THE SANTA FE URBAN RENEWAL PLAN AND FUTURE MILL LEVY USE IN URBAN RENEWAL PLANS.

WHEREAS, the city council may, by resolution, enter into contracts with other governmental bodies to furnish or receive government services, to make or pay charges for such service or enter into cooperative or other joint activities with other governmental bodies;

WHEREAS, Littleton Public Schools wishes to enter into an intergovernmental agreement concerning the inclusion of agricultural land into the Santa Fe Urban Renewal Plan and future mill levy use in urban renewal plans;

WHEREAS, South Suburban Recreation District wishes to enter into an intergovernmental agreement concerning the inclusion of agricultural land into the Santa Fe Urban Renewal Plan and future mill levy use in urban renewal plans;

WHEREAS, Urban Drainage & Flood Control District wishes to enter into a letter agreement concerning the inclusion of agricultural land into the Santa Fe Urban Renewal Plan; and

WHEREAS, the city council has determined that it is in the best interest of the city to enter into the intergovernmental agreements with Littleton Public School and South Suburban Parks and Recreation District and the letter agreement with Urban Drainage and Flood Control District;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

Section 1. The Intergovernmental Agreement for Use of TIF Revenues for School District Purposes between the City of Littleton, Littleton Invests for Tomorrow and Littleton Public Schools is hereby approved.

Section 2. The Intergovernmental Agreement for Use of TIF Revenues for Recreation District Purposes between the City of Littleton, Littleton Invests for Tomorrow and South Suburban Park and Recreation District is hereby approved.

Section 3. The letter agreement between the City of Littleton and Urban Drainage and Flood Control District is hereby approved.
