7 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**
8 **LITTLETON, COLORADO, SETTING THE BALLOT TITLE TO**
9 **SUBMIT TO THE ELECTORS OF THE CITY FOR THE MARCH 3,**
10 **2015 SPECIAL ELECTION AN AMENDMENT TO INCLUDE THE**
11 **ADDITION OF A NEW SECTION OF THE CITY CHARTER**
12 **REGARDING URBAN RENEWAL.**

14 **WHEREAS**, on August 8, 2014, the city clerk's office received a statement of intent
15 to circulate a petition to amend the city charter by adding a new section 64.5 entitled "Urban
16 Renewal";

17
18 **WHEREAS**, on November 5, 2014, the citizens filed a petition with the city clerk to
19 submit a charter amendment to the electors of the city;

20
21 **WHEREAS**, in accordance with the Municipal Home Rule Act, C.R.S. §§ 31-2-201,
22 et seq. (the "Act") the city clerk certified to the city council that the petition is valid and sufficient;

24 **WHEREAS**, the Act requires the city council to set the ballot title at its next
25 meeting, following certification of the petition by the city clerk; and

27 **WHEREAS**, the city council desires to set the ballot title for the proposed charter
28 amendment;

30 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE**
31 **CITY OF LITTLETON, COLORADO, THAT:**

33 **Section 1:** City council hereby sets the following ballot title for the March 3, 2015
34 special election for the proposed charter amendment:

36 **SHALL THE LITTLETON CITY CHARTER BE AMENDED TO INCLUDE THE FOLLOWING**
37 **NEW SECTION: SECTION 64.5 URBAN RENEWAL:**

39 **ANY COUNCIL ACTION APPROVING OR MODIFYING AN URBAN RENEWAL PLAN**
40 **PURSUANT TO PART 1 OF THE COLORADO URBAN RENEWAL LAW MUST BE**
41 **RATIFIED BY THE REGISTERED ELECTORS OF THE CITY OF LITTLETON IF THE**
42 **APPROVAL OR MODIFICATION OF THE URBAN RENEWAL PLAN PROPOSES THE USE**
43 **OF OR CHANGE TO EMINENT DOMAIN, CONDEMNATION, TAX INCREMENT**
44 **FINANCING, REVENUE SHARING, OR COST SHARING**

1 **Section 2:** : The city council hereby authorizes and directs the officers of the city to certify
2 on or before January 2, 2015 the ballot title in substantially the form set forth in Section 1 to the
3 County Clerks in Arapahoe, Jefferson and Douglas Counties. Such ballot title shall be submitted to
4 the eligible electors of the city at the March 3, 2015 special election.
5

6 **Section 3:** The city clerk is hereby directed to provide notice of the election in conformance
7 with the Act.
