Conclusion

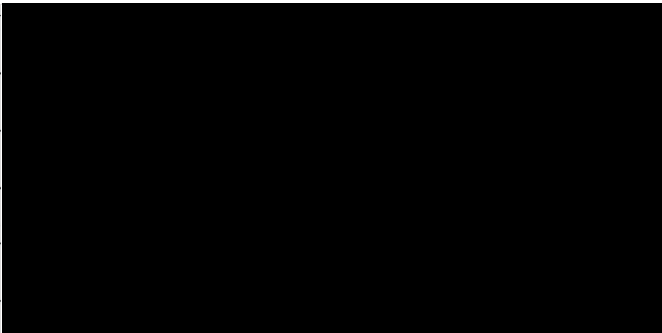
There was overall consensus that the project was appropriate and that it would improve the property and would not be detrimental to the neighborhood.

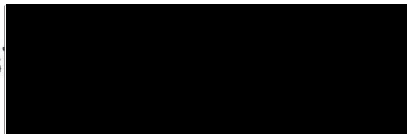

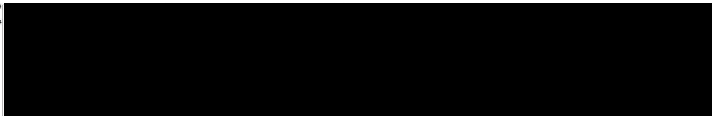

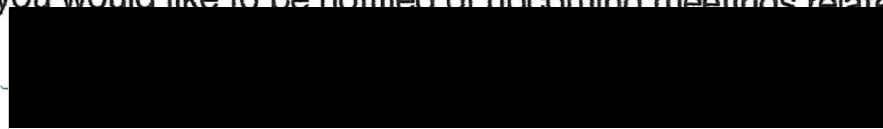
