9 **AN ORDINANCE OF THE CITY OF LITTLETON,**
10 **COLORADO, CHANGING THE NAME OF EAST**
11 **FREMONT AVENUE IN LITTLETON VILLAGE TO EAST**
12 **FREMONT PLACE**

14 **WHEREAS,** Littleton Village Final Subdivision Plat was approved on July 1,
15 2014 with a street named East Fremont Avenue;

16
17 **WHEREAS,** East Fremont Avenue already exists in the City of Centennial
18 approximately two blocks north of Littleton Village; and

20 **WHEREAS,** the city council desires to reduce confusion for emergency services
21 and the surrounding communities.

23 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
24 **THE CITY OF LITTLETON, COLORADO, THAT:**

26 **Section 1:** Section 5 of chapter 3 of title 8 of the Littleton City Code is hereby
27 amended by the addition of “East Fremont Avenue” under the “PRESENT STREET NAME”
28 column, and “East Fremont Place” under the “CHANGED TO” column.

30 **Section 2:** Severability. If any part, section, subsection, sentence, clause or
31 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
32 validity of the remaining sections of this ordinance. The City Council hereby declares that it
33 would have passed this ordinance, including each part, section, subsection, sentence, clause or
34 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
35 clauses or phrases may be declared invalid.

37 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in
38 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
39 repealer clauses of such ordinance nor revive any ordinance thereby.
