INTRODUCED BY COUNCILMEMBERS: STEIN & STAHLMAN

AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO, TO BE KNOWN AS THE "ANNUAL APPROPRIATION BILL" FOR ALL MUNICIPAL PURPOSES OF THE CITY OF LITTLETON, COUNTIES OF ARAPAHOE, DOUGLAS, AND JEFFERSON, STATE OF COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2015 AND ENDING DECEMBER 31, 2015.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

**Section 1:** There shall be and is hereby appropriated from and out of the general revenues derived from taxation in the City of Littleton, Colorado, to be obtained from the mill levy of 6.662 mills on each dollar of valuation of all taxable property within said City, and heretofore levied, and from franchises, licenses, fees, fines, grants, surplus and other sources of money or revenue of said City during the fiscal year commencing January 1, 2015, the following sums of money are deemed necessary to satisfy the expenses and liabilities of said City for said fiscal year. The sum or sums of money so appropriated for the various funds of the City are:

3       **Section 2:** Severability. If any part, section, subsection, sentence, clause or  
4 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the  
5 validity of the remaining sections of this ordinance. The City Council hereby declares that it  
6 would have passed this ordinance, including each part, section, subsection, sentence, clause or  
7 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,  
8 clauses or phrases may be declared invalid.

10       **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in  
11 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the  
12 repealer clauses of such ordinance nor revive any ordinance thereby.
