23	Section 1: Section 20 of chapter 5 of title 7 is hereby deleted in its entirety
24	and replaced with the following: "7-5-20: ANNUAL SANITARY SEWER SERVICE
25 26	CHARGES: Annual sanitary sewer service charges shall be set annually by council resolution."
26 27	Section 2: Severability. If any part, section, subsection, sentence, clause or
28	phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
29	validity of the remaining sections of this ordinance. The City Council hereby declares that it
30 31	would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
32	clauses or phrases may be declared invalid.

34 35	Section 3: Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
36	repealer clauses of such ordinance nor revive any ordinance thereby.
