7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,
8 COLORADO, APPROVING THE FIRST AMENDMENT TO THE
9 AGREEMENT BETWEEN THE CITY OF LITTLETON AND MILE HIGH
10 FLOOD DISTRICT REGARDING FUNDING OF MAJOR DRAINAGEWAY
11 PLANNING AND FLOOD HAZARD AREA DELINEATION FOR
12 SLAUGHTERHOUSE GULCH
13

14 WHEREAS the council may, be resolution, enter into contracts with other
15 governmental bodies to furnish or receive government services, to make or pay charges for such
16 services, or enter into cooperative or other joint activities with other governmental bodies; and
17

18 WHEREAS, the Littleton City Council approved an intergovernmental agreement
19 by and between the Mile High Flood District and the City of Littleton, in co-sponsorship with
20 Southeast Metro Stormwater Authority, to update the Major Drainageway Plan and Flood Hazard
21 Area Delineation of the Slaughterhouse Gulch watershed on August 20, 2024 (the “Original
22 Agreement”); and

24 WHEREAS, the parties now desire to amend the Agreement to provide for
25 additional funding, as set forth in Exhibit “A.”
26

27 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
28 THE CITY OF LITTLETON, COLORADO, THAT:
29

30 Section 1. The first amendment to the Intergovernmental Agreement between the
31 City of Littleton and Mile High Flood District Regarding Funding for Major Drainageway
32 Planning and Flood Hazard Area Delineation for Slaughterhouse Gulch is hereby approved, in
33 substantially the same form as Exhibit “A” and the Mayor is hereby authorized to execute the
34 intergovernmental agreement.

36 Section 2. The Resolution shall take effect upon its approval by the Littleton City
37 Council.
