Program Description *

Love INC organizes 42 active partner churches and other non-partner churches to aid our community by meeting needs through transactional service in a hands up rather than hands out mode. Our Helpline (Connection Center), receives thousands of calls each year, from which we identify gaps in service, calling on over 340 volunteers into action. Many families and individuals need quality, free, delivered furniture. And other community members have quality furniture they no longer need. Since Jan 2021, Love INC's furniture program, through volunteer movers, has picked up furniture from generous donors, warehouses it (with needed repair and cleaning) and delivers it to families in need. Love INC accepts referrals from nineteen local churches, schools, faith based and government agencies to provide much needed furniture, thereby serving those in need in our community.

The 2025 cost to provide this furniture service to our community is \$48,000 and increases annually due to increasing expenses for warehouse rent, insurance and supervision for volunteers, supplies, and administrative support. Expense for vehicles or gas is donated by the volunteer moving teams. Love INC is exploring the purchase of a truck this year, and in the beginning stages of searching for a new warehouse to increase capacity. This support from the City of Littleton ensures the continuation of this valuable service to our community: for the meaningful volunteer activity of the moving teams, for those generous community members who donate their furniture, and for those receiving furniture.

Other Funding Sources*

No additional funding sources were received in 2024. The furniture is donated; and volunteer moving teams from local churches donate their time, their trucks to pull the Love INC trailer, and the gas used during pick-ups and deliveries. Churches, individual donors and Renewed Treasures (RT) Resale Store support Love INC and the budget which includes these expenses. General donations 10% from churches, 46% from individual, 26% from RT.

Funds were used to support the furniture ministry by covering expenses for rent of warehouse, insurance and general administrative support, such as supervision of volunteers, training, and supplies. Through the generous support of the City of Littleton, numerous families were able to finally live independently in new homes with furniture, many for the first time. One recipient was quoted as saying. "We've been sleeping on the floor and using totes to keep our clothes in and also as makeshift tables. This furniture you delivered is so nice. My family can finally feel at home!" Love INC is committed to continuing this much needed and satisfying ministry.

Program Description *

Since 2017, Change the Trend Network has brought community stakeholders together around the mission of lessening the impact of homelessness in the Littleton, Englewood & Sheridan communities. This initial group eventually commissioned a working group to begin regular meetings focused on building cross-sector collaboration & increasing regional capacity to respond to the issue. Today, CTT meets weekly & consist of 40-50 attendees, representative of the service provider community in Littleton, Englewood, Sheridan, & beyond. Over the last several years, Change the Trend has played an integral role in supporting the work of the Tri-Cities Homelessness Policy Group, development of the Tri-Cities Homelessness Action Plan, & coordination of many projects within the plan including a coordinated outreach team, greater data-tracking capacity, Built-for-Zero, BridgeHouse Ready to Work, Tri-Cities Navigation Center & more. In total, this plan projects to place over 100 people into housing yearly.

Change the Trend requests \$10,500 to hire a Director to build the organization and continue operations of our network of service providers to work in conjunction with the Tri-Cities Homelessness Policy Group to build and maintain a collaborative, cross-sector approach to addressing homelessness in the Englewood, Littleton, and Sheridan communities. The last two years, CTT provided facilitation, and it was managed by a designated service provider. The last two service providers who provided leadership had to close down their organization. In light of the shifting uncertainty of non-profit organizations in the current financial and political climate, it is imperative now more than ever to increase the support of Change the Trend leadership with a permanent part time position. This will allow more hours of support, collaboration, troubleshooting and contingency planning in a dedicated position to support the region.

Program Description *

The Arapahoe Food Security Coalition includes 100+ members from 60+ organizations, initially focused on Littleton, Englewood, and Sheridan, with plans to expand countywide. It was created to strengthen coordination, encourage resource-sharing, and build a more connected, efficient food system. Its mission is to unite partners to end food insecurity by supporting emergency food providers through resources and collaboration.

Improving storage and distribution is key to increasing access and reducing waste. A food hub—a centralized facility that aggregates, stores, distributes, and sometimes markets food—can support local systems and improve access to healthy, affordable food.

The coalition seeks to hire a consultant to begin planning a regional food hub to serve emergency food providers supporting Littleton residents.

How would the funds be used?*

If applying for stadium district funds, how would the funds be used to support youth activity programs? (1,000 character limit)

A consultant with expertise in community engagement and food systems will be hired to research food hub models, coordinate Denver Metro site visits, and host virtual meetings with hubs nationwide. They will assess local needs for aggregation, cold/dry storage, and last-mile distribution for hunger relief efforts, including pantries, backpack programs, and community meals.

The consultant will develop a plan and timeline for designing a warehouse that supports equitable food access for organizations serving Littleton residents. This includes identifying locations, infrastructure needs, and operational models.

A coalition subcommittee will ensure community voices guide the process. The consultant will also explore partnerships in logistics, storage, and transportation to boost regional capacity, especially for perishables. Insights from this work will shape a Littleton-based food hub to serve as a regional anchor for long-term food security.

Family Tree supports individuals and families in Littleton and across the Denver metro area as they navigate and overcome the interconnected issues of child abuse, domestic violence, and homelessness. Our multigenerational services and 2-Gen model promotes housing stability, well-being, economic security, and stronger community connections. We strengthen families through parent education and in-home support; support survivors with shelter, legal advocacy, and safety planning; and assist people experiencing homelessness with emergency shelter, case management, and housing navigation. Our services are trauma-informed and client-centered, ensuring people receive the right support at the right time. By addressing the complex, overlapping challenges our clients face, we help them build lasting safety and long-term self-sufficiency.

Family Tree works with people with histories of poverty, trauma, and/or crises who do not fit a specific profile. However, internal data determined by our intake process indicates we serve primarily female-headed single-caregiver households (74%); adults between 26–45 years old (59%); and folks who have annual incomes under \$20,000 at intake (61%). We also serve the children of our adult clients, and more than 2,500 children received services last year. When people are navigating the physical, mental, and emotional weight that crises can carry, it can be difficult to focus on securing resources or planning for the future rather than simply trying to make it through each day. The City of Littleton's grant investment is essential to Family Tree's ability to serve low-income Littleton households and support vulnerable residents with the services they need to achieve and maintain stability and success.

Family Tree is grateful to have received \$2,700 for our 2025 fiscal year. Funding was used for direct program expenses, integrated services, and resources to support more than 170 individuals and families in Littleton who were experiencing crisis and trauma related to child abuse, domestic violence, and homelessness.

Through the SafeCare® and Community Family Resource Team (CFRT) programs, Family Tree provided Littleton residents with education, financial and supportive resources, home visitation, and case management to help stabilize families and successfully divert youth from further child welfare system involvement. Family Tree's Roots of Courage, Legal Advocacy, and Domestic Violence Outreach programs provided domestic violence survivors in Littleton with crisis intervention, advocacy, outreach, and emergency shelter. Littleton residents experiencing or at-risk of experiencing homelessness received comprehensive case management, employment guidance, rental and utility assistance, and helpline services through Family Tree's Homelessness Program. Family Tree's House of Hope and GOALS residential programs provided shelter and supportive services including housing placement for Littleton families experiencing homelessness. These programs also achieved the following outcomes during our last fiscal year:

73% of enrolled clients completed at least one SafeCare® topic, proving a significant increase in parenting skills (Goal=70%).

89% of Domestic Violence Outreach Program (DVOP) survey respondents reported they increased their knowledge of community resources (Goal=90%).*

96% of households in the Homelessness Program exited to safe and stable housing (Goal=80%). *Survey results represent responses from all (aggregated) clients surveyed in each program. We cannot report results specific to Littleton residents due to the confidentiality of our surveys.

Food Bank of the Rockies respectfully requests \$10,000 from the City of Littleton to support the purchase of fresh produce for distribution within Littleton. Fresh produce is distributed through two channels:

1. Hunger Relief Partner Network: We work with twelve partners in Littleton, including Arapahoe Community College, Open Arms Food Bank, and Waterstone Community Church.
2. Direct Service Programs: Fresh produce is an important component of several of Food Bank of the Rockies' direct service programs, including:

☐ Mobile Pantries, which help close the meal gap in communities where the need is greater than the capacity of existing resources. We operate one mobile pantry in Littleton at St. James Presbyterian Church

☐ Culturally Responsive Food Initiative, which procures and distributes culturally responsive food items to meet the needs of neighbors of diverse backgrounds. Fresh produce is an important part of many cultures' food preferences.

Other Funding Sources *

Currently, we have no pending or secured funding for fresh produce purchasing exclusively for distribution in the City of Littleton.

FRESH is funded by unrestricted and restricted donations from philanthropic donors. Food Bank of the Rockies uses a full spectrum of fundraising methods that generate revenue from intentionally diverse sources. We have a robust, year-round fundraising program and a portfolio of individuals, corporations, foundations, and government agencies that regularly support the organization's operations. The purchasing of fresh produce is integral to fulfilling our mission and will be sustained beyond the funding period through the generous support of our donors.

This funding helps us respond to a growing and urgent need in Littleton. In just one year, the number of Littleton residents we serve has increased by 18%, and we now expect to deliver more than 70,000 meals in the city alone. A grant of \$15,000 will support the preparation and delivery of approximately 5,000 of those meals, directly impacting neighbors who are aging alone, have serious mobility issues, or have financial challenges. At the same time, requests for our supplemental services, grocery boxes, pet food, and shelf-stable meals, continue to rise, now more than 40% higher than the previous year.

We are working hard to meet this growing demand without interruption, but rising food and transportation costs make it increasingly difficult. Your support allows us to continue showing up, every day, without fail, for hundreds of Littleton residents who rely on that knock at the door.

Nourish Meals on Wheels receives funding from a diverse mix of sources. Approximately 21% of our revenue comes from individual, corporate, and community group donations. Another 20% is raised through annual fundraisers, including our Fall Appeal and Theater Night. Foundation grants account for 28% of revenue, government grants 8%, and meal donations from clients 21%. We also receive in-kind food contributions valued at 2% of our annual revenue.

The \$7,800 Local Partnership grant awarded in 2023 helped Nourish Meals on Wheels sustain and adapt our services as need continued to rise. That funding ensured our team could keep delivering more meals, offer supplemental support like grocery boxes and pet food, and absorb rising food and fuel costs without disruption. But beyond the numbers, the City's investment helped us remain a consistent, trusted presence in the lives of neighbors like Kim, a Littleton resident we've served for 15 years.

When Kim lost her ability to drive due to MS in her early 50s, her world changed overnight. The isolation was overwhelming, and the fear was real. But thanks in part to the support of this grant, she's never had to face that fear alone. Today, she calls our volunteers her friends, says she "feels we know her better than her biological family," and describes Nourish as her family. Your funding helped make that possible. It's not just about meals, it's about showing up, year after year, for people who rely on that connection to survive and thrive.

Additionally, NLP began offering Conversational English classes for parents in Fall 2024, with over 40 participants and growing demand. Classes are family-friendly and held alongside youth programming to increase accessibility. NLP also introduced Spanish classes at the request of community partners. With the launch of the Bilingual Language Arts program, NLP is learning firsthand the power of language exchange in building community. The program helps Spanish-speaking parents develop conversational English while also offering Spanish lessons for English speakers. Many Spanish learners now support the English classes, creating a vibrant, cross-cultural fellowship. A 30-minute conversation time allows both groups to practice, connect, and build friendships.

Every year, Outdoor Lab introduces thousands of sixth-grade students to the transformative benefit of spending time in nature. The Foundation is particularly focused on making sure our under-resourced and marginalized students can attend Outdoor Lab free of cost. 32% of Jeffco sixth-grade students qualify for free and reduced lunch (FRL). Nearly half of all participating sixth-grade classes have an FRL rate of 50% or more. The Foundation anticipates that approximately 1,500 sixth-grade students will be eligible for FRL next year and will require tuition assistance to participate in Outdoor Lab. In Littleton, we anticipate nearly 25% of approx. 900 participating sixth-graders will qualify for FRL, requiring tuition assistance for 1 in 4 students to attend the program.

In addition, the cost of tuition to attend Outdoor Lab continues to increase. In 2025-26, tuition will increase to \$325 per student. During the 2024-25 schoolyear, unpaid FRL tuition costs for Littleton-area students totaled approx. \$67,000. Participating schools include: Bradford, Deer Creek, Falcon Bluffs, Ken Caryl, and Summit Ridge.

Other Funding Sources *

Every year, the Foundation secures funds from diverse sources of revenue to increase support for our program. First, we engage with both local and national corporate partners. We have recently received corporate support from King Soopers, Safeway, Walmart, Waste Management, Clove & Twine, Powder7, and FirstBank.

Second, the Foundation works with local foundations and local governments to fund our strategic priorities. We have received consistent support from the largest municipalities in Jefferson County – Arvada, Golden, Lakewood, Wheat Ridge, and Westminster. Private foundation support includes the Benson Family Foundation, Colorado Gives Foundation, and Jeffco Open Space Foundation.

Third, we raise philanthropic funds from donors who give in a variety of ways. This includes our annual gala that raises approximately \$100,000, our annual "Colorado Gives Day" campaign, and our individual giving program.

Whiz Kids requests program support to continue offering one-to-one tutoring and mentoring for students living below the poverty line in Littleton. WK serves students at six sites in Littleton, including 1) Littleton 1st Presbyterian, 2) Littleton United Methodist, 3) Grace Point, 4) Bethany, 5) Calvary, and 6) Horizon, which serve 125 students total among Field Elementary, Little Raven Elementary, and Centennial Elementary.

Funds will support volunteer recruitment, training, and oversight; creation of student materials; stipends for liaison teachers at partner schools; background checks; student incentives; and volunteer appreciation efforts. Whiz Kids helps students engage in school as confident learners with a sense of hope and purpose. The program focuses on literacy, math, and homework help while fostering mentoring relationships that build resilience and social-emotional skills

As a well-established organization with decades of experience, Whiz Kids has developed a robust and diverse revenue infrastructure to sustain its programming long-term. Through tailored academic support, mentorship, and resources, the program aimed to improve educational outcomes for these students. In the 2024-2025 academic year, Whiz Kids served a total of 504 elementary and middle school students across 37 tutoring sites in six counties, with 100 of these students being from within the City of Littleton. This success was made possible by the dedication of 710 volunteers, including 260 new tutors, who collectively provided 28,200 hours of tutoring and site management. Of these, 110 tutors served in the Littleton sites.

The funds will help cover the costs of running the soccer camp, making it accessible to all local families, regardless of their financial situation. As we seek to bless our neighbors and build relationships, it is our desire that no one will be excluded based on financial constraints.

The camp is staffed entirely by volunteers, so there is no staffing cost, but each camper receives a t-shirt and backpack as well as a free dinner for their entire family each night. (Food is the greatest single expense in the camp budget.) There is also a need to purchase a small amount of equipment each year to replace worn out soccer balls, pennies, cones, etc.

The average cost per participant is approximately \$100. We only charge \$25-40 per camper (depending on financial need) so the remainder of the cost must be subsidized through grants and donations.

We will use the funds to continue our investment in critical instrument upgrades to support student participation in our band program. For the coming year, we are requesting funds to address woodwind and additional percussion instrument needs. These instruments are typically provided by the school, as students are not expected—nor often able—to purchase them individually. New equipment boosts student morale, enhances performance quality, and ensures more meaningful experiences for all participants. Most of our woodwind instruments are over 20 years old and heavily worn from constant use. Replacing them will provide students with the tools they need to succeed in this impactful youth music program.

The PoL receives limited budget monies from Littleton High School. Student members pay an annual band fee. These monies do not cover the full expenses associated with running a comprehensive marching band program that serves a diverse student membership. LBW fundraises to help fill the funding gap but is not yet able to support the significant investment in new equipment.

This included replacing a vibraphone that was over 65 years old and no longer functional, as well as updating aged-out low brass instruments that had deteriorated due to decades of use. These upgrades had an immediate impact, improving the quality of our rehearsals and performances and allowing more students to participate fully with reliable, high-quality instruments.

Activities include reading, STEM, outdoor adventures, and college exposure. The HIGH SCHOOL LEADERSHIP PROGRAM offers paid summer roles and year-round college/career prep. NLP also partners with Eagle Lake Camps for a week of immersive nature-based growth through activities like canoeing, climbing, and ropes courses. Camp builds confidence, reduces stress, and fosters independence. Across all programs, students gain critical life skills, connect with mentors, and experience belonging in a safe, supportive, and empowering community.

Other Funding Sources *

North Littleton Promise is committed to long-term impact through consistent programming and deep-rooted relationships. NLP leverages its relationships with individual donors, local churches, foundation grants, and city partnerships to sustain its initiatives. NLP's growing network of volunteers and alumni also help extend capacity while strengthening community ownership. The 2025 stadium funds are actively supporting NLP's summer session, which currently serves 51 students. Each morning, students participate in math and literacy enrichment activities. In the afternoons they take part in leadership lessons and hands-on projects, such as maintaining the NLP garden. Fifth graders work weekly with seniors at Parkinson's Point, leading strength and balance exercises. The program also includes field trips to the Denver Museum of Nature and Science, the Children's Museum, Wings Over the Rockies, Town Hall Arts Theater, and Pirate's Cove. Additionally, students enjoy hikes and sessions with guest educators.

We are requesting \$27,600 to support three key offerings of our Crescendo Project for Littleton students:

- Free concert tickets for families: We'll provide complimentary tickets to mainstage concerts for Littleton students, families, and teachers. This spring, over 40 attended.
- In-school concerts: We'll present five assemblies in partnership with LPSD teachers, reaching approx. 1,750 students. These interactive performances introduce instruments and spark continued musical participation.
- Discovery Concerts: We'll offer 1,000 students tickets to immersive concerts in April and November 2026. First invitations go to the district's three Title I schools, with remaining tickets offered to 24 additional elementary schools.

Budget: \$1,000 for concert tickets; \$21,600 for five in-school concerts (4 musicians @ \$1,080 each); \$5,000 for two Discovery Concerts.

All funds will be used by the end of the 2026 funding cycle, in accordance with the City's grant guidelines.

Whiz Kids (WK) provides one-to-one tutoring, mentoring, and spiritual support to students living below the literacy and poverty lines. The program builds academic skills, confidence, and meaningful relationships to help students experience lasting hope and a brighter future. Core components include: the Tutoring, Mentoring, and Academic Support Program, where trained volunteers offer individualized support; Club Time (optional), offers age-appropriate, faith-based messages and activities; and Student Enrichment, including events such as the annual Whiz Kids Rodeo. WK operates six sites in the City of Littleton, providing consistent, caring support to help young people thrive in school and in life.

The best example of WK's program is through students like Karla. Karla was a WK student for three years at our Bethany site 18 years ago. She grew so much academically and found a love for teaching. She is now a teacher in Littleton Public Schools and came back to tutor at the same site!

Whiz Kids requests program support to continue offering one-to-one tutoring and mentoring for students living below the poverty line in Littleton. WK serves students at six sites in Littleton, including 1) Littleton 1st Presbyterian, 2) Littleton United Methodist, 3) Grace Point, 4) Bethany, 5) Calvary, and 6) Horizon, which serve 125 students total among Field Elementary, Little Raven Elementary, and Centennial Elementary.

Funds will support volunteer recruitment, training, and oversight; creation of student materials; stipends for liaison teachers at partner schools; background checks; student incentives; and volunteer appreciation efforts. Whiz Kids helps students engage in school as confident learners with a sense of hope and purpose. The program focuses on literacy, math, and homework help while fostering mentoring relationships that build resilience and social-emotional skills.

Other Funding Sources*

As a well-established organization with decades of experience, Whiz Kids has developed a robust and diverse revenue infrastructure to sustain its programming long-term. The organization collaborates with longstanding funders and experienced development consultants to secure funding for all initiatives. In FY 2024, Whiz Kids' revenue sources included Individual Contributions (35%), the IRS Employee Retention Credit (24%), Foundations (14%), Events (8%), Government Grants (7%), Business/Corporations (7%), Churches (3%), and Interest (2%). This diversified funding strategy ensures the stability and continuity of Whiz Kids' programs even beyond the exhaustion of specific grant awards.

Grant funds were used to support programming at WK's six tutoring sites in Littleton, serving under-resourced students particularly vulnerable to academic failure. Through tailored academic support, mentorship, and resources, the program aimed to improve educational outcomes for these students. In the 2024-2025 academic year, Whiz Kids served a total of 504 elementary and middle school students across 37 tutoring sites in six counties, with 100 of these students being from within the City of Littleton. This success was made possible by the dedication of 710 volunteers, including 260 new tutors, who collectively provided 28,200 hours of tutoring and site management. Of these, 110 tutors served in the Littleton sites.
