7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
8 LITTLETON, COLORADO, APPROVING AN AMENDMENT TO AN
9 INTERGOVERNMENTAL AGREEMENT WITH MILE HIGH FLOOD
10 DISTRICT REGARDING DESIGN AND CONSTRUCTION OF
11 DRAINAGE AND FLOOD CONTROL IMPROVEMENTS FOR SOUTH
12 PLATTE RIVER AT REYNOLDS LANDING

15 WHEREAS, the Council may, by resolution, enter into contracts with other
16 government bodies to furnish or receive governmental services, to make or pay for charges for
17 such services and to enter into cooperative or joint activities with other government bodies; and
18

19 WHEREAS, the City of Littleton desires to enter into an agreement with Mile
20 High Flood District to contribute funds to the design and construction of improvements at for the
21 South Platte River at Reynolds Landing, with expected amendments to encumber future funds;

24 WHEREAS, the City’s 2020 share of the costs of the project, as set forth in the
25 Agreement, shall be a contribution of \$100,000 towards design and construction of the
26 improvements, \$90,000 of which is from an Arapahoe County Open Space planning grant for
27 Superchi parcel.

29 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
30 THE CITY OF LITTLETON, COLORADO, THAT:

32 The amendment to the Agreement Regarding Final Design and Construction of
33 Drainage and Flood Control Improvements for South Platte River at Reynolds
34 Landing, City of Littleton, Agreement No. 14-01.24D is hereby approved.
