**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LITTLETON, COLORADO, AUTHORIZING THE APPROVAL OF
AMENDMENT NUMBER ONE TO THE 2016 ARAPAHOE COUNTY
COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM
SUBGRANTEE AGREEMENT FOR THE PRENTICE AVENUE
SIDEWALK PROJECT**

WHEREAS, Arapahoe County (the "County") has entered into a grant agreement (the "Grant Agreement") with the United States Department of Housing and Urban Development ("HUD") for financial assistance to conduct a Community Development Block Grant Program (the "CDBG Program") pursuant to Title I of the Housing and Community Development Act of 1974 (the "Act") as amended, and the Rules and Regulations promulgated by HUD governing the conduct of Community Development Block Grants ("CDBG") programs, 24 Code of Federal Regulations ("FR") Part 570, as amended, (the "Rules and Regulations");

WHEREAS, the SubGrantee agreed to complete the project known as Littleton Sidewalk Improvements (Project) and entered into a Community Development Block Grant Agreement (Agreement) with the County, dated March 8, 2017; and

WHEREAS, the SubGrantee has requested the balance of Littleton's 2016 Set-Aside funds from the Littleton Doctors Care project be added to the Littleton Sidewalk Improvement project. This amendment will increase the Littleton Sidewalk Improvements grant amount by the balance of Doctors Care unspent grant (\$4,260) from \$114,750 to \$119,010.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

The 2016 Arapahoe County Community Development Block Grant Program Subgrantee Agreement Amendment Number One between the City and Arapahoe County for the Prentice Avenue Sidewalk project be approved, and the Mayor be authorized to affix her signature thereto.
