8 A RESOLUTION OF THE CITY OF LITTLETON,
9 COLORADO, ADOPTING THE URBAN DRAINAGE AND
10 FLOOD CONTROL DISTRICT FLOOD HAZARD AREA
11 DELINEATION REPORT, BIG DRY CREEK
12 DOWNSTREAM OF COUNTY LINE ROAD, DATED
13 FEBRUARY 2018

15 WHEREAS, the City of Littleton has been a participating community in the
16 National Flood Insurance Program since 1978, when floodplain maps were established in the
17 City; and

18
19 WHEREAS, both the Urban Drainage and Flood Control District and Federal
20 Emergency Management Agency have delineated floodplains within the city of Littleton, and
21 those delineations are subject to revision and update; and

22
23 WHEREAS, the city and Urban Drainage and Flood Control District conducted a
24 study to update the Big Dry Creek floodplain with portions within the city limits, titled “Flood
25 Hazard Area Delineation Report, Big Dry Creek downstream of County Line Road”, dated
26 February 2018; and

27
28 WHEREAS, the Urban Drainage and Flood Control District Board approved the
29 revision to the floodplain study for Big Dry Creek in April 2018, and recommended to the
30 Colorado Water Conservation Board for adoption; and

31
32 WHEREAS, the Colorado Water Conservation Board adopted the revision to the
33 Big Dry Creek floodplain by Resolution FPR 18-693 on January 4, 2019; and

35 WHEREAS, the City of Littleton must now adopt and begin to regulate the 2018
36 revision of the Big Dry Creek floodplain.

38 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
39 THE CITY OF LITTLETON, COLORADO, THAT:

41 The Flood Hazard Area Delineation Report, Big Dry Creek downstream of
42 County Line Road, dated February 2018, is hereby approved.
