16	Charter related to neighborhood land use; and		
17			
18	WHEREAS, on July 31, 2025 a sufficient number of signatures were verified and		
19	issued a Statement of Sufficiency by the city clerk requiring the item to be placed on the ballot for		
20	the November 4, 2025 regular election; and		
21			
22	WHEREAS, the Colorado State Constitution and Colorado state statutes convey		
23	to local governments the authority to regulate local land use planning and zoning; and		
24			
25	WHEREAS, ballot measure 3A seeks to lock in land uses to an arbitrary date of		
26	January 1, 2025; and		
27			
28	WHEREAS, ballot measure 3A also seeks to mandate voter elections for city-		
29	initiated rezonings or text amendments in our residential zoning districts; and		
30			
31	WHEREAS, ballot measure 3A's mandated election requirements risk the City's		
32	ability to comply with state law requirements putting the City at risk of costly litigation and		
33	government funding opportunities; and		
34			
35	WHEREAS, the City's code and state law already provide remedies for citizens		
36	who oppose certain land use changes by way of public hearings, citizen initiatied ordinance		
37	changes, amendments to ordinances, elections of council members, and referendums for council		
38	passed ordinances already; and		
39			
40	WHEREAS, ballot measure 3A would be one of the restrictive land use measure		
41	contained in a City's charter in the state of Colorado.
