7 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**
8 **LITTLETON, COLORADO, AUTHORIZING AN**
9 **INTERGOVERNMENTAL AGREEMENT BETWEEN THE DOUGLAS**
10 **COUNTY CLERK AND RECORDER AND THE CITY OF LITTLETON**
11 **REGARDING THE CONDUCT AND ADMINISTRATION OF THE**
12 **NOVEMBER 6, 2018 COORDINATED ELECTION.**

14 **WHEREAS**, pursuant to the Uniform Election Code of 1992 (Articles 1 to 13 of
15 Title 1 C.R.S.) as amended, governmental entities are encouraged to cooperate and
16 consolidate elections in order to reduce taxpayer expenses;

17
18 **WHEREAS**, pursuant to the Colorado Constitution Article XIV, Section
19 18(2)(a), and Section 29-1-203, C.R.S., as amended, the Douglas County Clerk and the
20 City of Littleton may cooperate or contract with each other to provide any function,
21 service or facility lawfully authorized to each, and such contract may provide for the
22 sharing of costs, the imposition of taxes, and incurring of debt;

23
24 **WHEREAS**, pursuant to Section 67 of the Littleton City Charter, the city council
25 by resolution, may enter into contracts with other governmental bodies to furnish or
26 receive governmental services, to make or pay charges for such services and to enter into
27 cooperative or other joint activities with other governmental bodies; and,

29 **WHEREAS**, the Douglas County Clerk and Recorder and the City of Littleton
30 desire to set forth their respective responsibilities for the coordinated election to be held
31 on November 6, 2018;

33 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF**
34 **THE CITY OF LITTLETON, COLORADO, AS FOLLOWS:**

36 Section 1. The Intergovernmental Agreement between the Douglas
37 County Clerk and Recorder and the City of Littleton Regarding the Conduct and
38 Administration of the November 6, 2108 Coordinated Election is hereby approved and
39 Mayor Brinkman is hereby authorized to execute such intergovernmental agreement.

41 Section 2. The city shall participate in the coordinated election to be
42 held on November 6, 2018, in accordance with the terms and conditions of the
43 intergovernmental agreement, and hereby adopts the exclusive use of the Uniform
44 Election Code of 1992 (Articles 1-13 of Title 1, C.R.S.) with respect to such election.

45
46 Section 3. The city's designed election official shall be the city clerk, who is

1 hereby authorized and directed to carry out the terms of the intergovernmental
2 agreement and to take all such actions as are necessary or desirable to effectuate
3 the election as a coordinated election to be held on November 6, 2018
