7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,
8 COLORADO, APPROVING AN INTERGOVERNMENTAL JOINT
9 COOPERATION AGREEMENT AND HOME CONSORTIUM
10 AGREEMENT BETWEEN ARAPAHOE COUNTY, COLORADO, AND THE
11 CITIES OF CENTENNIAL, ENGLEWOOD, GLENDALE, GREENWOOD
12 VILLAGE, LITTLETON, SHERIDAN, AND THE TOWN OF DEER TRAIL,
13 COLORADO, RELATING TO THE CONDUCT OF COMMUNITY
14 DEVELOPMENT BLOCK GRANT PROGRAM AND HOME INVESTMENT
15 PARTNERSHIPS PROGRAM FOR FEDERAL FISCAL YEARS 2025
16 THROUGH 2027

18 WHEREAS, the council may, by resolution, enter into contracts with other
19 governmental bodies to furnish or receive governmental services, to make or pay charges for such
20 services, or enter into cooperative or other joint activities with other governmental bodies; and

22 WHEREAS, the city council desires to participate in Arapahoe County's
23 Community Development Block Grant (CDBG) and Home Investment Partnerships (HOME)
24 programs from 2025 through 2027; and

26 WHEREAS, the program requires the City of Littleton to enter into an
27 intergovernmental joint cooperation agreement with Arapahoe County, Colorado, and the Cities
28 of Centennial, Englewood, Glendale, Greenwood Village, Sheridan, and the Town of Deer Trail,
29 Colorado, to set forth the parties' duties and responsibilities with respect to the programs.

31 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
32 THE CITY OF LITTLETON, COLORADO, THAT:

34 The Intergovernmental Joint Cooperation Agreement and Home Consortium
35 Agreement between Arapahoe County, Colorado, and the Cities of Centennial, Englewood,
36 Glendale, Greenwood Village, Littleton, Sheridan, and the Town of Deer Trail, Colorado, and the
37 City of Littleton relating to the conduct of the Community Block Grant Program and Home
38 Investment Partnerships Program for federal fiscal years 2025 through 2027 is approved.
