15	WHEREAS, pursuant to the Uniform Election Code of 1992 (Articles 1 to 13 of
16	Title 1 C.R.S.) as amended, governmental entities are encouraged to cooperate and consolidate
17	elections in order to reduce taxpayer expenses; and
18	WHEDEAS involuent to the Coloredo Constitution Article VIV. Section 19 (2)(a)
19 20	WHEREAS , pursuant to the Colorado Constitution Article XIV, Section 18 (2)(a), and Section 29-1-203, C.R.S., as amended, the Jefferson County Clerk and the City of Littleton
20 21	may cooperate or contract with each other to provide any function, service or facility lawfully
22	authorized to each, and such contract may provide for the sharing of costs, the imposition of taxes,
23	and incurring of debt; and

25	WHEREAS, pursuant to Section 67 of the Littleton City Charter, the city council
26	may, by resolution, enter into contracts with other governmental bodies to furnish or receive
27	governmental services, to make or pay charges for such services and to enter into cooperative or
28	other joint activities with other governmental bodies; and

30	WHEREAS, the Jefferson County Clerk and Recorder and the City of Littleton
31	desire to set forth their respective responsibilities for the coordinated election to be held on
32	November 7, 2023.
33 34	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
35	THE CITY OF LITTLETON, COLORADO, THAT:
36	
37	Section 1. The Intergovernmental Agreement for Coordinated Election between
38	the Jefferson County Clerk and Recorder and the City of Littleton is hereby approved, and the
39	mayor is hereby authorized to execute such intergovernmental agreement.
40	
41	Section 2. The city shall participate in the coordinated election to be held on
42	November 5, 2024, in accordance with the terms and conditions of the intergovernmental
43	agreement, and hereby adopts the exclusive use of the Uniform Election Code of 1992 (Articles 1-
44	13 of Title 1, C.R.S.) with respect to such election.
45	
46	Section 3. The city's designated election official shall be the city clerk, who is

- take all such actions as are necessary or desirable to effectuate the election as a coordinated election
