19	in shared programs through intergovernmental agreements such as the shared Tri-Cities
20	Homelessness Policy Committee; and

22	WHEREAS, the City of Englewood has developed a sustainability program which
23	included the development of a Sustainability Plan, hiring a Sustainability Coordinator, and
24	launched several sustainability-related programs including a Green Business Program that the City
25	of Littleton is interested in sharing the coordinator position with the City of Englewood; and

27	WHEREAS, the City of Littleton wishes to partner with the City of Englewood on
28 29	sustainability related initiatives; and
30	WHEREAS, the City of Englewood's Green Business Program could be scaled to
31	fit the needs of the City of Littleton; and
32	in the needs of the City of Entheton, and
33	WHEREAS, sharing a Green Business Program would achieve economies of scale
34	for both cities; and

36	WHEREAS, the City of Littleton established the Environmental Stewardship
37	Board as an advisory board to provide input to the Littleton City Council and staff on natural
38	environmental stewardship priorities for the community.

40	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
41	THE CITY OF LITTLETON, COLORADO, THAT:

43	The Intergovernmental Agreement between the Cities of Englewood and Littleton
