20 21 22 23 24	Section 1: There is hereby submitted to the vote of the registered electors of the City of Littleton at the regular election to be conducted on November 3, 2015 a ballot question proposing an amendment to Section 60 of the Littleton City Charter.	
25	Section 2:	The official ballot shall contain the following ballot question:
26 27 28 29	Shall Section 60 of the Littleton City Charter be amended so that the sale or conveyance of open space property must be approved at an election, unless it is sold or conveyed for other public use?

34 35 36 37 38	Section 3: The City Council hereby authorizes and directs the officers of the City to certify on or before September 4, 2015 the ballot question in substantially the form set forth in Section 2 to the County Clerks in Arapahoe, Douglas and Jefferson Counties.	
39 40	Section 4: necessary or appropr	The officers of the City are authorized and directed to take all other action riate to effectuate the provisions of this ordinance.
41 42 43 44	Section 5: If a majority of the registered electors voting at the election on November 3, 2015 vote "yes" in response to the ballot question in Section 2, the Littleton City Charter shall be amended as follows:	
45 46	Sec. 60.	Restriction on Sales of Land and Water Rights.

1 2 Lands granted to, purchased, acquired by the City for use, or used by the City, for 3 park or open space purposes, shall not be sold or conveyed without a majority 4 vote of the people, except they may be sold or conveyed, for other public use by 5 ordinance adopted in regular procedure. No water rights granted to, purchased or 6 acquired by the City shall be sold or conveyed without a majority vote of the 7 people. Nothing in this provision, however, shall prevent the City from 8 exchanging water rights without a vote of the people. Other real property of the 9 city shall be sold only by ordinance adopted in regular procedure, not using the 10 emergency provision. 11

Section 6: Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

19 Section 7: Repealer. All ordinances or resolutions, or parts thereof, in conflict with 20 this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer 21 clauses of such ordinance nor revive any ordinance thereby. 22
