How would the funds be used? *

Doctors Care will use funds to increase access to quality, affordable health care and program support services for low-income, underserved children, youth, and adults in Littleton, Colorado. Doctors Care is dedicated to serving individuals and families on Medicaid, CHP+, or uninsured and putting them on a path towards long-term wellness. Your support helps provide integrated primary healthcare in our medical clinic (which includes dental and behavioral health services) and health access programs for Littleton's most vulnerable populations.

Other Funding Sources *

The Doctors Care financial model maintains three separate funding streams: fundraising (i.e., foundations, community organizations, and individual donors), medical reimbursements (Medicaid, CHP+, and sliding-fee scale), and donated care by volunteerism. Currently, major foundation partnerships include, Connect for Health Colorado, Arapahoe County Government, and the Anschutz Foundation.

Summary of how prior year's funds and/or in-kind services were used. *

In 2021, the clinic had 7,080 visits for medical, dental, and behavioral health care. Nearly 50% of those visits were from Littleton residents.

COVID-19 negatively impacted the healthcare system by creating massive workforce shortages across the country, including Colorado. In the fall of 2021, Doctors Care completed a workforce compensation study to help the organization maintain staff and be competitive in the industry. The findings of the study have resulted in increased costs of \$150,000 for the organization, which will be increased financial pressure carried forward into 2022 and beyond.

In 2021, attributed lives to Doctors Care by Medicaid rose due to the increased number of individuals qualifying for Medicaid during the pandemic. This, along with the hard work and dedication of staff, helped increase the number of reimbursements received, allowing Doctors Care to stabilize this source of revenue and utilize it to help fill anticipated gaps from decreased earned and charitable income. While Medicaid income has helped offset some shortfall in 2021, those earnings for 2022 are unknown, as the continuation of the federal COVID-19 Public Health Emergency status is uncertain.

Doctors Care's adaptability and resiliency to operate throughout the pandemic resulted in positive outcomes for our patients and community. We appreciate the City of Littleton's support, which helped us to continue providing quality and affordable services for our community during unprecedented times.

All of Garden's programs are community based and designed to increase the independence, well-being and social integration of its participants. Able Chef is a sub-program of the Healthy Living program and works with participants on learning one recipe per month, allowing participants to fully learn and understand the recipe until they are able to independently go grocery shopping for the recipe, pay for the ingredients at the store and complete the recipe with limited support from Garden staff. The other sub-program consists of recreational activities that promote a fun, active lifestyle. Garden participants go hiking, rock climbing, ropes courses, yoga, swimming and more. Through these experiences participants gain confidence, conquer fears, learn how to make healthy choices, how to practice self-care and advocacy, how to budget, interact with community members, advocate for themselves in the community, learn public transportation skills and how to take care of their bodies. How would the funds be used? *

The funds will be used to directly support clients in our extended stay shelter and housing programs. Our shelter serves as a safe landing place for victims fleeing dangerous situations, and provides housing for up to 90 days. Staff provide for basic needs while facilitating access to critical social support systems through case management, referrals, and other supports to help increase self-sufficiency and transition out of shelter. Additionally, program staff provide psycho education about DV, and through the housing program specially trained navigators assist victims with securing vital documents, benefits such as SNAP and TANF and other supports while helping clients obtain permanent housing.

Specifically, funds will be used for food, hygiene products, and other items for clients as well as other shelter related direct costs such as furniture, beds, etc. Additionally funds will be used to cover the cost of securing vital documents for the clients, many of whom flee their situation with nothing in hand.

Note: In 2022, we transitioned to a new client management system to track data, better serve our clients and inform our programming. The majority of clients we serve are from Arapahoe county; however, they were not previously tracked at the city level. We can assume that a small percentage of those served are City of Littleton residents. Moving forward, we will make every effort to capture this information when possible, in addition to engaging in community outreach activities in surrounding areas to ensure people are aware of our services.

In addition to reading/math tutoring and spiritual mentoring, NLP now offers STEM enrichment academic activities. Over the past year we experienced significant challenges related to supply chain issues: food availability, unreliability of deliveries due to staffing issues, and now increased food costs. Overall food costs are up 25-30% and still rising. Monthly food costs have been averaging an additional \$5,000 per month and that is with our Chef who is experienced, and creative altering menus based on the food we can access. Increased food costs just to feed Littleton residents/clients equates to more than \$26,500 annually.

There is also less free food available from the food banks we have been relying on. Passing on cost increases to our clients is not an option with a majority of our clients living on a fixed income. We are hoping that the City of Littleton would consider funding this grant for \$25,000 to help us offset the rise in food costs allowing us to serve even more seniors in need.

The funding we received last year helped us serve 59,163 meals to 378 Littleton Residents. We were also able to launch a new breakfast meal delivery program. Five easily prepared or ready to eat breakfast meals are provided weekly. Approximately 150 clients participate in this new program. 75% of breakfasts are delivered at no cost to clients. Only 13% are reimbursed by clients or their family at the full \$3 per meal. We hear clients are happy to have breakfast, as many have morning medications that need to be taken with food.

A popular program at RMSC is the Aphasia Book Club which helps survivors improve cognitive and communication skills, while also returning to a pre-stroke activity that they loved. The book club provides weekly social connection and peer support without the stigma that is sometimes associated with therapeutic activities such as a support group. Adaptive reading options such as audiobooks and large print, as well as reading guides to support comprehension make this club accessible to any stroke survivor.

One aspect of the partnership with Encompass Rehab Hospital is a stroke family education group that is intended for caregivers and loved ones. While the current book club is open to stroke survivors only, RMSC plans to utilize these funds to expand the book club to include family members and caregivers. The Family Book Club would include books specifically chosen to educate families on topics relevant to stroke, recovery, and their new role as caregivers.

This program would be promoted to and serve both Encompass patients and families, and stroke survivors and families in the Littleton community. This group is facilitated by a social worker, so while it is social in nature, it also connects participants with needed community resources and mental health support. The funds from this grant would sponsor the program by covering the costs of the social work facilitator's time, which in addition to facilitating the club each week, involves promotion and outreach, planning time, preparation of reading guides and follow up on participant needs.

Other Funding Sources *

While 'City of Littleton Local Partnership Funds' is the sole funding source for the Family Book Club program, RMSC has partnered with additional organizations in Littleton such as Rotary Club of Littleton, Sertoma Club of Littleton, and Littleton Elks #1650 to fund similar rehabilitation programs. The Douglas H. Buck Community Recreation Center is also the venue for RMSC's weekly aquatic therapy program. Encompass Rehab Hospital has provided the funding for providing stroke support groups and an educational series, where the Family Book Club would be widely promoted.

With rising food costs, a goal to provide more fresh and higher quality food, including fruit and vegetables, and less / no food available from food banks, which previously provided free food for Arty's, and having to now pay rent for storage/assembly space we estimate the budget to be \$11,000 for the 2022 – 2023 school year.

As of August 1, ticket sales are not still not back to pre-COVID levels. THAC is an important financial anchor for Historic District as patrons dine and shop when they attend a performance. DIRT hosts three fundraisers a year as a way to sustain DIRT's programming but also to bring together our community and highlight the work and partnerships available to support neurodivergent community members. DIRT is requesting funding to support the two fundraisers that are intended to bring together community partners: Fans and Friends Trivia Night and DIG Deep Block Party. DIRT's annual Fans and Friends Trivia Night is hosted in April and is intended to provide a sensory-friendly night of fun to DIRT's fans, friends, and family. DIRT raises funds through ticket sales and sponsorships, but utilizes community members for location and hosting capabilities. For example, DIRT's 2022 Fans and Friends Trivia Night was hosted at Brewability. With several community sponsors and sold-out tickets, we were able to have organizations such as PASCO and Stepping Stones in attendance along with several past interns and their families. Trivia consisted of eight rounds, with each round hosted by an individual with a connection to DIRT (i.e. past intern, board member, community volunteer, etc). DIRT received overwhelmingly positive feedback on this event

and is anticipating our 2023 Trivia Night at a location that can hold more people. DIRT's second fundraiser of the year is our DIG Deep Block Party, which is designed to celebrate the anniversary of DIRT opening its doors to our brick-and-mortar location while highlighting small, local businesses in the Littleton community. Taking place every July, DIRT recently finished our 2022 DIG Deep Block Party and are pleased to announce the day was a huge success for both DIRT and our community partners. The day hosted a vendor market in our back parking lot that consisted of small businesses from Downtown Littleton, such as PlayForge Games, Waive the Grain, Savory Spice Shop, etc., and local organizations, such as Phamaly Theatre and Access Gallery. The event was elevated by live music performances from Littleton-based artists playing on our front patio with other games and entertainment available, along with a sensory bus for our neurodivergent community members who need a sensory-friendly place to relax. Approximately \$15,000 of the requested funds from this award would be used as a sponsorship for these two events in 2023, with name recognition and other sponsorship perks for the City of Littleton as packages are created.

With a second location opening and our IEP program expanding to include Pre-Employment Transition Services (Pre-ETS) in 2023, DIRT recently created and hired three new positions; two exclusively for IEP. Together with the Inclusive Employment Manager, the Inclusive Employment Coordinator and Job Development Coordinator creates a holistic program experience for each neurodivergent individual who goes through our program. Overseen by the Inclusive Employment Manager, the Inclusive Employment Coordinator acts as each intern's job coach throughout the internship. They work one-on-one with each individual and utilize a strengths-based approach and evaluation rubric to work on individualized skill sets. Following completion of the internship, graduates who choose to find permanent job placements in the community are supported by the Job Development Coordinator. This person works directly with each intern after graduation on resume building, applying to jobs, interview skills, etc. The Job Development Coordinator will also work with the Inclusive Employment Manager to offer Pre-ETS classes throughout the year, which will be available to any past or future intern who may feel that they need a bit of extra time to master a skill prior

to finding a permanent job. The remaining of the requested funds from this grant would be used to support this increased capacity at our Littleton location and will ultimately allow DIRT to increase the number of neurodivergent individuals served each year without diminishing the quality of our programming.

Other Funding Sources *

DIRT budgets an allocated amount dedicated to hosting our fundraisers, which ensures that all proceeds from the fundraiser through ticket sales, sponsorships, donations, etc. are always going back into our programming. In addition to the support we receive from our community through fundraisers, DIRT's programs are supported by several community funding organizations, including the Daniels Fund, the Denver Foundation, the Lowe Fund, Developmental Pathways, and more.
