7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,
8 COLORADO, AUTHORIZING AN INTERGOVERNMENTAL
9 AGREEMENT BETWEEN THE CITY OF LITTLETON AND THE COUNTY
10 OF DOUGLAS REGARDING COST SHARING FOR THE CONSTRUCTION
11 OF THE COUNTY LINE ROAD (BROADWAY TO UNIVERSITY)
12 PROJECT

14 WHEREAS the council may, be resolution, enter into contracts with other
15 governmental bodies to furnish or receive government services, to make or pay charges for such
16 services, or enter into cooperative or other joint activities with other governmental bodies; and

17
18 WHEREAS the City of Littleton is partnering with Douglas County to widen and
19 reconstruct County Line Road from Broadway to University (the “Project”); and

20
21 WHEREAS the current estimated cost estimated cost to construct the Project is
22 Thirty-Four Million Three Hundred Twenty-Five Thousand Dollars (\$34,325,000), which includes
23 consultant services during construction. This amount is subject to change as the design is finalized
24 and the County conducts its bid opening for the Project; and

26 WHEREAS Douglas County and the City of Littleton desire to enter into an
27 agreement, in which the City of Littleton will financially contribute to the Project, and to further
28 define the Parties role in relation to the Project, as further set forth in Exhibit “A.”

30 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
31 THE CITY OF LITTLETON, COLORADO, THAT:

33 Section 1. The foregoing recitals are incorporated herein as if set forth in fully.

35 Section 2. The Intergovernmental Agreement between the City of Littleton and
36 Douglas County Regarding Cost Sharing for the Construction of the County Line Road (Broadway
37 to University) Project is hereby approved, in substantially the same form as Exhibit “A” and the
38 mayor is hereby authorized to execute the intergovernmental agreement.
