# BACKGROUND

In 2021, The cities jointly developed and adopted the Tri-Cities Homelessness Plan of Action which ran through the end of 2024.

The Tri-Cities partnered with Arapahoe County, Metro Denver Homeless Initiative, and many nonprofit service providers to achieve success in many components of the plan, including empowering a Tri-Cities Homelessness Coordinator, who oversaw the management and implementation of the plan.



"Being homeless has changed my life. I saw a whole different side of the world. I knew people were homeless, but I didn't see the population. I had a false image of homelessness until I was homeless."



# TRI-CITIES EFFORTS

### Goals:

- Understand the homeless situation in the Tri-Cities
- Work to proactively ensure legislation is supportive and consistent in each of the Tri-Cities
- Collaboratively work across jurisdictions to create a coordinated approach with all stakeholders and implement promising strategies
- Support community education initiatives that provide two-way communication and learning

### Successes:

- During 2023-24, 57 individuals were housed representing 34% exit from homelessness, well above the 22% state percentage.
- Initiated Tri-Cities Homelessness Navigation Center and attracted Bridge House Ready to Work program
- Implemented Co-responder program



The homeless do not represent a narrow demographic.

Homelessness is associated with every region, racial group, and family status in the U.S. population.






## FOCUS MOVING FORWARD

- Develop long-term Tri-Cities governance model with financial sustainability
- Expand housing opportunities for single adults (i.e. Permanent Supportive Housing, Shared Housing, Landlord outreach)
- Streamline services for families experiencing homelessness

(Includes preventing families from becoming homeless, partnering with service providers and school districts, and expanding housing vouchers)

- Sharing performance metrics
  - Action items completed
  - Numbers of people receiving services
  - Safe Parking Pilot participation
  - Navigation Center use
  - Ready to Work participation and graduation rates
