**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LITTLETON, COLORADO, APPROVING AN INTERGOVERNMENTAL
AGREEMENT BETWEEN THE BEMIS PUBLIC LIBRARY AND THE
LITTLETON PUBLIC SCHOOLS REGARDING THE LITTLETON
ONECARD INITIATIVE**

WHEREAS, Bemis Public Library and Littleton Public Schools (LPS) are enthusiastic to increase collaboration between their respective overlapping communities; and

WHEREAS, the Library has a breadth of valuable resources that will provide LPS students with greater access to materials they need to be successful in school, to include access to databases in school or at home; downloadable materials; check out books; and use of Library computers and other technology; and

WHEREAS, the Library agrees to streamline student access to databases and materials; provide LPS with data about student participation; provide training related to the use of library resources; and work jointly and collaboratively with LPS to implement and communicate program policies, and to further strengthen the relationship between the Library and LPS; and

WHEREAS, LPS agrees to support implementation of the program by providing appropriate student data; distribute policies, goals, and awareness to all students and parents/guardians of LPS; and work jointly and collaboratively with the Library to implement and communicate program policies, and to further strengthen the relationship between the Library and LPS; and

WHEREAS, LPS will provide \$10,000.00 annually to the Library in order to share database and online resource costs; any additional expenses related to the provision of services incurred by the Library shall be the sole responsibility of the Library; and

WHEREAS, LPS Board of Education approved the Intergovernmental Agreement between Bemis Public Library and Littleton Public Schools regarding the Littleton OneCard Initiative on March 30, 2020.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
THE CITY OF LITTLETON, COLORADO, THAT:**

An Intergovernmental Agreement between the Bemis Public Library and the Littleton Public Schools regarding the Littleton OneCard Initiative is hereby approved.
