7 AN ORDINANCE OF THE CITY OF LITTLETON,
8 COLORADO, AS THE GOVERNING BODY OF THE CITY
9 OF LITTLETON SEWER UTILITY ENTERPRISE,
10 AMENDING THE 2025 SEWER BUDGET

12 WHEREAS, Ordinance No. 25, Series of 2024 established the annual
13 appropriation for municipal purposes for the City of Littleton, Colorado: and
14

15 WHEREAS, appropriations have theretofore been made for the expenditures of
16 monies pursuant to said budget: and
17

18 WHEREAS, the necessity of receiving and expending additional monies from the
19 general funds could not have been reasonably anticipated during the time of the adoption of the
20 budget and appropriation of funds in accordance therewith.

22 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
23 THE CITY OF LITTLETON, COLORADO, THAT:
24

25 Section 1: The budget of the City of Littleton for the fiscal year beginning January
26 1, 2025, and ending December 31, 2025, is hereby amended by the following additions:

FUND	EXPENDITURES
Sewer Utility Fund	\$5,159,792
Total	\$5,159,792

30 Section 2: The total budgeted expenditures for the City of Littleton, Colorado,
31 Sewer Utility Enterprise for the period of January 1, 2025, to December 31, 2025 shall be amended
32 to \$33,559,046.

34 Section 3: Severability. If any part, section, subsection, sentence, clause or
35 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
36 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
37 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
38 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
39 phrases may be declared invalid.

41 Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict
42 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
43 clauses of such ordinance nor revive any ordinance thereby.

INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council of the City of Littleton on the 6th day of May, 2025, passed on first reading by a vote of 7 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.

PUBLIC HEARING on the Ordinance to take place on the 20th day of May 2025, in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the hour of 6:30 p.m., or as soon thereafter as it may be heard.

PASSED on second and final reading, following public hearing, by a vote of FOR and __ AGAINST on the 20th day of May, 2025 and ordered published by posting at Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
