7	A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,
8	COLORADO, AUTHORIZING ACCEPTANCE OF THE QUIT CLAIM
9	DEED FROM THE CITY OF ENGLEWOOD, COLORADO IN
10	CONNECTION WITH THE ENGLEWOOD CITY DITCH PROJECT
11	
12	WHEREAS, the City of Englewood ("Englewood") owns critical raw water
13	infrastructure ("City Ditch") that provides water supply to Englewood and other users, including
14	the City of Littleton ("Littleton"); and
15 16	WHEREAS, portions of the City Ditch are located within Littleton, for which
16 17	Englewood holds existing easements, both recorded and unrecorded; and
18	Englewood holds existing casements, both recorded and unrecorded, and
19	WHEREAS, Englewood has undertaken a project to enclose and relocate portions
20	of the City Ditch to a new alignment within Littleton; and
21	of the Orly Ditch to a new anglinicht within Dittletoin, and
22	WHEREAS, to accommodate the new City Ditch alignment, the Parties have, by
23	separate agreement, entered into a Relinquishment and Grant of Easements to provide Englewood
24	with easement rights for the new alignment as well as to relinquish easement rights to Littleton for
25	areas of the existing areas of City Ditch that are to be abandoned by Englewood as a result of the
26	new alignment; and
27	
28	WHEREAS, Littleton desires to accept the Quit Claim Deed, attached hereto and
29	in substantially the same form as Exhibit "A," to memorialize the relinquishment of certain
30	property back to the City of Littleton, as more specifically outlined within the Relinquishment and
31	Grant of Easements Agreement.

33	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
34	THE CITY OF LITTLETON, COLORADO, THAT:
35	
36	Section 1. The Littleton City Council hereby accepts the document titled "Quit
37	Claim Deed", attached hereto, and in substantially the same form as Exhibit A. The mayor is
38 39	hereby authorized to execute said agreement.
