9 AN ORDINANCE OF THE CITY OF LITTLETON,  
10 COLORADO, AMENDING ORDINANCE NO. 28 SERIES  
11 OF 2013 KNOWN AS THE “ANNUAL APPROPRIATION  
12 BILL” FOR ALL MUNICIPAL PURPOSES OF THE CITY  
13 OF LITTLETON, COUNTIES OF ARAPAHOE,  
14 JEFFERSON AND DOUGLAS, STATE OF COLORADO,  
15 FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2014  
16 AND ENDING DECEMBER 31, 2014.

19 WHEREAS, Ordinance No. 28, Series of 2013 established the annual  
20 appropriation for municipal purposes for the City of Littleton, Colorado, as amended by  
21 Ordinance No. 41, Series of 2014;

22  
23 WHEREAS, appropriations have theretofore been made for the expenditures of  
24 monies pursuant to said budget; and

25  
26 WHEREAS, the necessity of receiving and expending additional monies from the  
27 various funds could not have been reasonably anticipated during the time of adoption of the  
28 budget and appropriation of funds in accordance therewith;

30 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
31 THE CITY OF LITTLETON, COLORADO, THAT:

33 Section 1: The budget of the City of Littleton for the fiscal year beginning  
34 January 1, 2014, and ending December 31, 2014, is hereby amended by additions to the  
35 following funds:

Property & Liability Fund	\$ 420,000
Total	\$ 2,932,000

1                   **Section 2:**     The provisions of the annual appropriations Ordinance No. 28,  
2 Series of 2013, as amended by Ordinance No. 41, Series of 2014, are hereby amended with the  
3 total of all fund expenditures amended to \$79,321,790.

6 of the City of Littleton on the 2<sup>nd</sup> day of December, 2014, passed on first reading by a vote of 7
