45 <b>Section 1:</b> The foregoing recitals are hereby adopted by the City Council as
46 findings in support of the adoption of this Ordinance.

## **Section 2**: The City Council further finds and declares that:

a. The city's current laws, ordinances, rules and regulations may not adequately address the issues and challenges associated with protecting the character of Littleton or ensuring a healthy mix of diversity among its commercial retail; and

b. The city may suffer irreparable harm if a short, temporary moratorium, as herein described, is not imposed to prevent land-use activities detrimental to the character of the City of Littleton being pursued prior to the implementation of permanent regulations; and

c. This ordinance is necessary and proper to provide for the safety, preserve the health, promote the prosperity, and welfare of the City of Littleton and the inhabitants thereof; and

d. The duration of the extension of the moratorium imposed by this Ordinance is reasonable in length and is no longer than is required for the city to properly investigate, develop, and, if appropriate, adopt and implement any regulations deemed necessary with respect to the subject matter addressed herein; and

e. Property owners within the City of Littleton will not be unfairly prejudiced by the imposition of the short, extension of this temporary moratorium imposed by this Ordinance.

**Section 3**: Upon the effective date of final passage of this Ordinance, an extension of the moratorium is imposed on the submission, acceptance, processing, or approval of any new application related to fuel sales (retail) within the City of Littleton. City staff and all applicable commissions, boards, departments, divisions, and representatives are directed to refuse to accept for filing, and not to process or review, any such new applications during the moratorium period.

**Section 4**: The moratorium imposed by this extension shall commence as of the effective date of this Ordinance, and shall expire in 180 days, unless extended or sooner repealed.

**Section 5:** The City Council hereby finds, determines and declares that it has the power to adopt this Ordinance pursuant to: (i) the Local Government Land Use Control Enabling Act, Article 20 of title 29, C.R.S.; (ii) Part 3 of Article 23 of title 31, C.R.S. (concerning municipal zoning powers); (iii) Section 31-15-103, CR.S. (concerning municipal police powers); (iv) Section 31-15-40, CR.S. (concerning municipal police powers); (v) the authority granted to home rule municipalities by Article XX of the
