23	6.662 mills on each dollar of valuation of all taxable property within said City, and heretofore
24	levied, and from franchises, licenses, fees, fines, grants, surplus and other sources of money or
25	revenue of said City during the fiscal year commencing January 1, 2016, the following sums of
26	money are deemed necessary to satisfy the expenses and liabilities of said City for said fiscal
27	year. The sum or sums of money so appropriated for the various funds of the City are:
