14	WHEREAS, pursuant to the Colorado Open Meetings Law, §§ 24-6-401, et seq.,
15	C.R.S., as amended, the City of Littleton, as a local public body, is required to give timely and
16	adequate notice of its meetings; and
17	
18	WHEREAS, pursuant to § 24-6-402(2)(c) C.R.S., as amended, "a local public
19	body shall be deemed to have given full and timely notice if the notice of the meeting is posted in
20	a designated public place within the boundaries of the local public body no less than twenty-four
21	hours prior to the holding of the meeting. The public place or places for posting such notice shall
22	be designated annually at the public body's first regular meeting of each calendar year"; and
23	
24	WHEREAS, pursuant to section 1-3-2 of the Littleton City Code, "For the
25	purposes of the charter and this code, except where publication in a newspaper is specifically
26	required by the charter, an ordinance or state statute, the terms "publication", "publish" or
27	"published" shall mean a minimum of two (2) of the following three (3) methods: a) posting on
28	the city's website; b) physical posting at the Littleton Center, Bemis public library and the Littleton
29	municipal courthouse; or c) publication in a newspaper of general circulation in the city".

31	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
