An Amendment to Littleton City Code Title 10, Chapters 1 and 7, Regarding Site Development Plans

Staff presentation: Mike Sutherland, Deputy Community Development Director

Chair Rudnicki opened the public hearing at 8:32 p.m.

Pam Chadbourne - Pre-application meeting is not public transparent / the 300 ft radius is too small and every case is different; not a one-size-fits-all / Eight (8) units is far too many; this is not a minor impact on a residential neighbor / 10 days is too short for notification

Chair Rudnicki closed the public hearing at 8:34 p.m.

Commissioner Reynolds moved and Commissioner Stahlman seconded to approve PC Resolution 08-2019, amending Littleton City Code Title 10, Chapters 1 and 7, regarding site development plans, which forwards a favorable decision to city council, with the the following conditions: 1. Add new subsection "J" to section 10-7-2(B)(2) requiring the submittal of any documents required to demonstrate compliance with Littleton's operating standards and the site development plans approval criteria; 2. For major applications the final decision date shall be defined as the date the applicant provides certification of mailing to nearby property owners to the city; 3. For major applicaitons the appeal period shall be 20 days.

Amendment: Commissioner Stahlman moved and Chair Rudnicki seconded to amend the motion to extend the notification range from 300 feet to 600 feet excluding rights of way or easements. Vote on the amendment: 2-4 with Commissioners Reynolds, Bolt, Coronato, and Miller voting no. The motion fails.

Amendment: Commissioner Miller moved and Commissioner Coronato seconded to amend the site development plan definition under major development, item 2 to read "All Multi-family development in any zone having more than three

dwelling units ..." <Commissioner Miller withdrew his motion to amend>

Commissioner Reynolds moved and Commissioner Stahlman seconded to amend the motion to exclude rights of way and easements from the 300 feet notification range. Vote on the amendment: 5-1 with Commissioner Bolt voting no. The motion carries.

Vote on the main motion: 6-0. The motion carries unanimously.
