7 AN ORDINANCE OF THE CITY OF LITTLETON,
8 COLORADO, APPROPRIATING FUNDS FOR THE 2024
9 ANNUAL BUDGET FOR ALL MUNICIPAL PURPOSES OF
10 THE CITY OF LITTLETON, COUNTIES OF ARAPAHOE,
11 DOUGLAS, AND JEFFERSON, STATE OF COLORADO,
12 FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2024
13 AND ENDING DECEMBER 31, 2024

15 WHEREAS, Ordinance No. 24, Series of 2023 established the annual
16 appropriation for municipal purposes for the City of Littleton, Colorado: and

17
18 WHEREAS, Ordinance No. 12, Series of 2023 amended the annual appropriation
19 for municipal purposes for the City of Littleton, Colorado: and

21 WHEREAS, appropriations have theretofore been made for the expenditures of
22 monies pursuant to said budget: and

24 WHEREAS, the necessity of receiving and expending additional monies from the
25 general funds could not have been reasonably anticipated during the time of the adoption of the
26 budget and appropriation of funds in accordance therewith.

28 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
29 THE CITY OF LITTLETON, COLORADO, THAT:

30
31 Section 1: The budget of the City of Littleton for the fiscal year beginning January
32 1, 2024, and ending December 31, 2024, is hereby amended by the following additions:

36 Section 2: The provisions of the annual appropriations Ordinance No. 24,
37 Series 2023 The total budgeted expenditures for the City of Littleton, Colorado for the period of
38 January 1, 2024 to December 31, 2024 shall be amended to \$158,540,224.

40 Section 3: Severability. If any part, section, subsection, sentence, clause or

41 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
42 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
43 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
44 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
45 phrases may be declared invalid.

47 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
48 with this ordinance are hereby repealed, provided that this repealer shall not repeal the
49 repealer clauses of such ordinance nor revive any ordinance thereby.

51 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
52 of the City of Littleton on the 16th day of July, 2024, passed on first reading by a vote of ____
53 FOR and ____ AGAINST; and ordered published by posting at Littleton Center, Bemis Library,
54 the Municipal Courthouse and on the City of Littleton Website.

55 PUBLIC HEARING on the Ordinance to take place on the 6th day of August, 2024,
56 in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the
57 hour of 6:30 p.m., or as soon thereafter as it may be heard.

59 PASSED on second and final reading, following public hearing, by a vote of ____ FOR and
60 ____ AGAINST on the 6th day of August, 2024 and ordered published by posting at Littleton Center,
61 Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
