**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,
COLORADO, APPROVING A REVOCABLE LICENSE AGREEMENT
BETWEEN THE CITY OF LITTLETON AND THE TOWN OF COLUMBINE
VALLEY FOR INSTALLATION OF A LICENSE PLATE READER
CAMERA AT THE INTERSECTION OF WATSON LANE AND BOWLES
AVENUE**

WHEREAS the council may, by resolution, enter into contracts with other governmental bodies to furnish or receive government services, to make or pay charges for such services, or enter into cooperative or other joint activities with other governmental bodies; and

WHEREAS the City of Littleton (“City”) is the owner of South Watson Lane, located in Littleton, Arapahoe County, Colorado, (“Property”); and

WHEREAS The Town of Columbine Valley (“Town”) wishes to enter onto the Property to install a license plate reader camera on an existing light pole located on the Property or on a pole to be installed by the Town on the Property.

WHEREAS pursuant to the Charter of the City, any license granted by the City must be revocable at will by the City; and

WHEREAS the Town has complied with the application procedures set forth in Section 8-1-5 of the City Code and the City is willing to grant a revocable and non-exclusive license to the Licensee under the terms, conditions, and limitations as specified herein.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
THE CITY OF LITTLETON, COLORADO, THAT:**

Section 1. The foregoing recitals are incorporated herein as if set forth in fully.

Section 2. The Revocable License Agreement between the City of Littleton and the Town of Columbine Valley regarding installation of a License Plate Reader Camera at the intersection of South Watson Lane and West Bowles Avenue is hereby approved, in substantially the same form as Exhibit “A” and the mayor is hereby authorized to execute the intergovernmental agreement.
