18	Jamison Avenue and Horseshoe Park open space property to extend utility facilities to the		
19	Littleton Village development; and		
20	WHEREAS areating of the assessments would allow Veel Engage to better		
21	WHEREAS, granting of the easements would allow Xcel Energy to better		
22 23	operate their facilities to serve the Littleton Village development;

33	validity of the remaining sections of this ordinance. The city council hereby declares that it

35	phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,		
36 37	clauses or phrases may be declared invalid.		
38	Section 3: Repealer. All ordinances or resolutions, or parts thereof, in		
39	conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the		
40	repealer clauses of such ordinance nor revive any ordinance thereby.
