On 11/03/2018 at approximately 2235 hours, I was dispatched to The Toad Tavern (5302 South Federal Circle #A) reference an intoxicated individual that fell and was unconscious.  
  
INVESTIGATION BY OFFICER C. CORREA 201705  
  
Upon arrival, I observed a male laying unconscious on the floor, next to the bar. The individual was breathing but could not regain his consciousness. Bystanders advised me that the male fell from a high single stool, which was next to the bar.  
  
LFR arrived on scene and began medically assessing the male. I found his wallet in his pocket and positively identified him as Ryan Joseph Nino ( ).  
  
I cleared Ryan via LPD Dispatch and I was advised that there was an active protection order (PNO/M1093962 - CIC/122780974, ISD/20180806, No Expiration) out of the City of Littleton with Ryan as the restrained party. The

miscellaneous field stated that Ryan "[...] shall not possess or consume alcoholic beverages [...]"

Ryan was transported to the Littleton Adventist Hospital by LFR and later placed into the ICU. Ryan did not have any visible injuries nor blood on his body.

I contacted the manager of the bar, Timothy Sean Ferry ( ), and asked him what Ryan consumed at the bar. Timothy told me that they only served him water and that when Ryan entered the bar he was already intoxicated.

I asked to speak with the bartender, Matthew Richard Need ( ). I asked Matthew what he served Ryan at the bar and Matthew replied, "Two shots of vodka." Matthew then provided me with a receipt for Ryan's drinks, which I attached to this report.

Matthew told me that after the two shots, he stopped serving Ryan due to his level of intoxication.

I contacted three witnesses, Janet Marjorie Lipson ( ), Suzanne M. Zoellner ( ) and Amy L. Neuser ( ).

Janet said that she was sitting with Suzanne, when they were approached by Ryan, who began hugging them. Janet said that he was "obviously intoxicated." Janet said that she saw when Ryan began to fall asleep, and at that point, she went to Matthew and told him to call a "Lyft" for Ryan. Janet said that when she turned back to Ryan, she saw him fall out of his chair. Janet stated that Matthew mentioned to her that he served Ryan 3 shots of vodka.

Suzanne stated that Ryan came in wanting to hug all the girls in her group. She stated she was a bartender for approximately 04 years and it was obvious to see that Ryan was significantly impaired. Suzanne stated she saw Ryan being served two shots. A little while later, she observed Ryan sitting on a stool, passing out and getting "wobbly." She said that Amy tried to help him but he fell to the ground, hitting his head. Suzanne said that she asked people around to call 911 and Timothy began pulling Ryan by the arm to see if he was truly passed out.

Amy stated that she was at the bar with her friends when Ryan came up and began hugging them. Ryan told Amy that his heart was broken and Amy began "coaching" him. Amy said that he was "obviously intoxicated" but was able to carry on a conversation, despite being unsteady on his feet. Amy said that an hour later she noticed that Ryan was slumping over on a bar stool and his head was "hanging down." Amy stated she was worried that Ryan would fell so she ran toward him and as soon as she got to him Ryan fell to the ground. Amy tried to catch him but she was barely able to break his fall.

Janet, Suzanne and Amy completed written statements.

I contacted Jeannette Morris ( ) and she told me that when Ryan entered the bar, he was already intoxicated. Jeannette also said that she did not see Ryan drink anything at the bar.

Irmgard Jaltob ( ) said that when Ryan entered the bar, he was "as drunk as a skunk." She also said that Ryan began trying to hug her.

I contacted the bar doorman, Pkoe Moon Vonseggen ( [REDACTED] ). Pkoe told me that when Ryan entered the bar, he was "relatively intoxicated", but still able to walk and keep his balance. After Ryan entered, Pkoe said that he went to Matthew and alerted him that Ryan was already intoxicated.

I issued Matthew a summons (#M1093140) for Sale to Intoxicated Persons 3-2-10 (F), which he signed and received a copy.

At the time of completion of this report, Ryan was still at the Littleton Adventist Hospital. The paperwork for Ryan's arrest was placed in the "To be served" box.
