7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,  
8 COLORADO, APPROVING A LICENSE AGREEMENT BETWEEN THE  
9 CITY OF LITTLETON AND ARAPAHOE COUNTY FOR  
10 TRANSPORTATION AND RIGHT-OF-WAY IMPROVEMENTS WITHIN  
11 THE HIGH LINE CANAL AT MINERAL AVENUE, IN WHICH  
12 SUPERSEDES AND TERMINATES TWO ASSOCIATED EXISTING  
13 LICENSE AGREEMENTS BETWEEN THE CITY OF LITTLETON AND  
14 DENVER WATER.

16 WHEREAS the council may, by resolution, enter into contracts with other  
17 governmental bodies to furnish or receive government services, to make or pay charges for such  
18 services, or enter into cooperative or other joint activities with other governmental bodies; and

19  
20 WHEREAS Arapahoe County owns the High Line Canal property within the  
21 boundaries of Arapahoe County, of which portions of the High Line Canal are located within the  
22 City of Littleton boundary; and

23  
24 WHEREAS the City of Littleton has constructed improvements within the High  
25 Line Canal at Mineral Avenue through the implementation of prior projects, including recently  
26 constructed improvements as part of the Mineral Mobility East Improvements Phase 1 project; and

27  
28 WHEREAS Arapahoe County and the City of Littleton desire to enter into a  
29 License Agreement, whereby Arapahoe County authorizes the City of Littleton to construct,  
30 utilize, maintain, and repair transportation and right-of-way improvements within the High Line  
31 Canal at Mineral Avenue, pursuant to the terms and conditions outlined in the agreement, attached  
hereto as Exhibit A.

33 WHEREAS because of a recent transition of ownership of the High Line Canal  
34 between Denver Water and Arapahoe County, Arapahoe County now owns portions of the High  
35 Line Canal located within the Arapahoe County boundary. Therefore, execution of this License  
36 Agreement (Exhibit A) between Arapahoe County and the City of Littleton supersedes and  
37 terminates two associated existing License Agreements between the City of Littleton and Denver  
Water for improvements within the High Line Canal at Mineral Avenue.

39 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
40 THE CITY OF LITTLETON, COLORADO, THAT:

41 Section 1. The foregoing recitals are incorporated herein as if set forth in fully.

43 Section 2. The License Agreement between the City of Littleton and Arapahoe  
44 County, regarding right-of-way and transportation improvements within the High Line Canal

45 property at Mineral Avenue is hereby approved, in substantially the same form as Exhibit “A” and  
46 the Mayor is hereby authorized to execute the intergovernmental agreement.
