7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,  
8 COLORADO, APPROVING THE RENEWAL OF PROPERTY/CASUALTY LIABILITY  
9 COVERAGE THROUGH COLORADO INTERGOVERNMENTAL RISK SHARING  
10 AGENCY (CIRSA)  
11

12 WHEREAS, pursuant to Section 1-15-62(a) of the Littleton Municipal Code, City  
13 Council approval is a condition precedent to the approval of an Agreement in which the total value  
14 of the Agreement is over five hundred thousand dollars and 00/100 cents (\$500,00.00); and  
15

16 WHEREAS, the City of Littleton contracts with an outside vendor to provide  
17 property/casualty liability coverage and related services to manage risk for the City; and  
18

19 WHEREAS, the Colorado Intergovernmental Risk Sharing Agency (“CIRSA”) is  
20 a municipal self-insurance pool that was formed by Colorado municipalities to provide insurance  
21 coverage, including risk management and risk assessment for its members to collectively manage  
22 costs and liability; and

24 WHEREAS, the City of Littleton has been a member of CIRSA since 1984; and  
25

26 WHEREAS, CIRSA has over 290 members including other municipalities and  
27 public entities; and  
28

29 WHEREAS, Littleton as a member organization wishes to renew coverage for the  
30 2026 calendar year with CIRSA.

32 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
33 THE CITY OF LITTLETON, COLORADO, THAT:  
34

35 Section 1. The Littleton City Council hereby approves the *renewal of*  
36 *property/casualty liability coverage through Colorado Intergovernmental Risk Sharing Agency*  
37 and authorizes the Mayor, to execute the same on behalf of the City of Littleton.

39 Section 2. The Resolution shall take effect upon its approval by the Littleton City  
40 Council.
