21 22 23 24	may cooperate or contract with each other to provide any function, service or facility lawfully authorized to each, and such contract may provide for the sharing of costs, the imposition of taxes, and incurring of debt; and
25 26 27 28 29	WHEREAS, pursuant to Section 67 of the Littleton City Charter, the city council may, by resolution, enter into contracts with other governmental bodies to furnish or receive governmental services, to make or pay charges for such services and to enter into cooperative or other joint activities with other governmental bodies; and
30 31 32	WHEREAS, the Douglas County Clerk and Recorder and the City of Littleton desire to set forth their respective responsibilities for the coordinated election to be held on November 4, 2025.
33 34 35 36	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:
37 38 39 40	Section 1. The Intergovernmental Agreement for Coordinated Election between the Douglas County Clerk and Recorder and the City of Littleton is hereby approved, and the mayor is hereby authorized to execute such intergovernmental agreement.
41 42 43 44	Section 2. The city shall participate in the coordinated election to be held on November 4, 2025, in accordance with the terms and conditions of the intergovernmental agreement, and hereby adopts the exclusive use of the Uniform Election Code of 1992 (Articles 1-13 of Title 1, C.R.S.) with respect to such election.
45 46	Section 3. The city's designated election official shall be the city clerk, who is
