15 16 17	WHEREAS , the ULUC replaced outdated zoning ordinances, consolidated and clarified existing regulations, and streamlined the development process to implement the City's policies as outlined within the Envision Littleton Comprehensive Plan; and
18 19 20 21 22 23 24 25	WHEREAS, since October 2024, staff from the City's Public Works & Utilities and Community Development departments have continued the effort to streamline the development process by drafting and proposing the Littleton Engineering Design Standards and Specifications ("LEDS" or "Standards and Specifications") to outline city requirements, design criteria, and implementation guidelines for public and private infrastructure construction within the City of Littleton; and
26 27 28 29 30	WHEREAS, the proposed Standards and Specifications provide minimum acceptable standards to safeguard life, health, property, and public welfare by regulating and controlling the design, construction, quality of materials, use, location, and maintenance of all public infrastructure and private improvements of common ownership; and
31 32 33	WHEREAS , on March 11, 2025, City staff discussed the proposed Standards and Specifications with the City Council of the City of Littleton, the benefit of adoption, and the proposed timeline for adoption; and
34 35 36 37	WHEREAS , a forty-five (45) day comment period was available to the public from June 13^{th} through July 28^{th} , 2025 ; and
38 39 40 41	WHEREAS , the City believes that the health, safety, and general welfare of the City and its citizens will be served by adoption of the Littleton Engineering Standards and Specifications.
