9 AN ORDINANCE OF THE CITY OF LITTLETON,  
10 COLORADO, ADOPTING THE 2014 EDITION OF THE  
11 NATIONAL ELECTRIC CODE, THE 2013 EDITION OF  
12 THE SAFETY CODE FOR ELEVATORS AND  
13 ESCALATORS, AND THE 2011 EDITION OF THE SAFETY  
14 STANDARD FOR PLATFORM LIFTS AND STAIRWAY  
15 CHAIRLIFTS.

17 WHEREAS, the purpose of the National Electric Code is to protect the public  
18 health and welfare by regulating the installation of electrical systems and components;

19  
20 WHEREAS, the purpose of the Safety Code for Elevators and Escalators is to  
21 protect the public health and welfare by regulating the design construction, installation,  
22 operation, testing, inspection, maintenance, alteration, and repair of elevators, dumbwaiters,  
23 escalators, moving walks, and material lifts;

25 WHEREAS, the purpose of the Safety Standard for Platform Lifts and Stairway  
26 Chairlifts is to protect the public health and welfare by regulating the installation, testing,  
27 inspection, maintenance, alteration, and repair of platform lifts and stairway chairlifts;

29 WHEREAS, new editions of the National Electric Code, the Safety Code for  
30 Elevators and Escalators and the Safety Standard for Platform Lifts and Stairway Chairlifts are  
31 available; and

33 WHEREAS, it is in the best interest of the health, safety and welfare of the  
34 residents of the City of Littleton to adopt the 2014, 2013, and 2011 updates, respectively, of the  
35 National Electric Code, the Safety Code for Elevators and Escalators and the Safety Standard for  
36 Platform Lifts and Stairway Chairlifts;

38 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
39 THE CITY OF LITTLETON, COLORADO, THAT:

41 Section 1: Section 4-1-1 (D) of the Littleton City Code is hereby repealed and  
42 reenacted to read:

44 (D) National Electric Code, 2014 Edition, of the National Fire Protection Association,  
45 including appendix chapters A, B, C, F, and G.

47 Section 2: Section 4-1-5 (E) of the Littleton City Code is hereby repealed and  
48 reenacted to read:

(E) Amendments to the 2014 National Electric Code: The following amendments are hereby adopted to the National Electric Code:

1. The administrative provisions to the 2014 National Electric Code are located in Title 4, Chapter 1, Section 5 (A) of the City of Littleton Municipal Code.

**Section 3:** Section 4-1-1 (J) of the Littleton City Code is hereby repealed and reenacted to read as follows:

(J) American National Standard Institute/American Society of Mechanical Engineers A17.1 - 2013 Safety Code for Elevators and Escalators and American Society of Mechanical Engineers A18.1 - 2011 Safety Standard for Platform Lifts and Stairway Chairlifts.

**Section 4:** Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

**Section 5:** Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.

INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council of the City of Littleton on the 20<sup>th</sup> day of January, 2015, passed on first reading by a vote of 7 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
