7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,  
8 COLORADO, APPROVING AN INTERGOVERNMENTAL AGREEMENT  
9 BETWEEN THE CITY OF LITTLETON AND THE CITY OF ENGLEWOOD  
10 REGARDING A FINANCIAL CONTRIBUTION FOR CONSTRUCTING THE  
11 2026 WINDERMERE BRIDGE JOINT REHABILITATION PROJECT

13 WHEREAS the council may, be resolution, enter into contracts with other  
14 governmental bodies to furnish or receive government services, to make or pay charges for such  
15 services, or enter into cooperative or other joint activities with other governmental bodies; and  
16

17 WHEREAS the City of Englewood will enter into a contract with a contractor for  
18 repair of construction joints on the Windermere Street Bridge over Big Dry Creek; and  
19

20 WHEREAS, the municipal boundary between the City of Littleton and the City of  
21 Englewood traverses a portion of said project, with each city being responsible for maintenance  
22 and repair within its jurisdiction; and

24 WHEREAS for purposes of mutual cost savings and construction efficiencies,  
25 Englewood has agreed to construct the Project; and  
26

27 WHEREAS the City of Englewood and the City of Littleton desire to enter into an  
28 agreement, in which Littleton will financially contribute to the Project, and to further define the  
29 Parties roles in relation to the Project, as further set forth in Exhibit "A;"  
30

31 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
32 THE CITY OF LITTLETON, COLORADO, THAT:

34 Section 1. The Intergovernmental Agreement between the City of Littleton and the  
35 City of Englewood regarding a financial contribution for constructing the 2026 Windermere  
36 Bridge Joint Rehabilitation Project is hereby approved, in substantially the same form as Exhibit  
37 "A" and the mayor is hereby authorized to execute the intergovernmental agreement.

39 Section 2. The Resolution shall take effect upon its approval by the Littleton City  
40 Council.
