7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,
8 COLORADO, APPROVING A FIRST AMENDMENT TO CONSTRUCTION
9 AGREEMENT FOR THE EMERGENCY REPAIR WORK AT JACKASS HILL ROAD
10 & MINERAL AVENUE, BROADWAY & JAMISON AVENUE, AND POWERS PARK
11 CITY PROJECT NOS. 23-75, 23-76, 23-77

13 WHEREAS, the city entered into an agreement with C&L Water Solutions, Inc.
14 (“Contractor”) on September 7, 2023 for Emergency Repair Work at Jackass Hill Road & Mineral
15 Avenue, Broadway & Jamison Avenue, and Powers Park, City Project Nos 23-75, 23-76, 23-77
16 (“Agreement”); and

18 WHEREAS pursuant to Section 1-15-62 of the Littleton Municipal Code, city
19 council approval is a condition precedent to the approval of an amendment of an agreement in
20 which the total value of the agreement is over five-hundred thousand dollars and 00/100 cents
21 (\$500,000.00); and

23 WHEREAS due to unknown conditions and unforeseen circumstances, there is a
24 need to amend the Agreement; and

26 WHEREAS, the city and Contractor have agreed to amend the Agreement as set
27 forth herein.

29 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
30 THE CITY OF LITTLETON, COLORADO, THAT:
31

32 Section 1. The Littleton City Council hereby approves the Amendment to the
33 Agreement by and between the City of Littleton and C&L Water Solutions, Inc., dated September
34 7, 2023, for Emergency Repair Work at Jackass Hill Road & Mineral Avenue, Broadway &
35 Jamison Avenue, and Powers Park, City Project Nos 23-75, 23-76, 23-77, in substantially the same
36 form attached hereto as Exhibit “A,” and authorizes the Mayor, or authorized designee, to execute
37 the same on behalf of the City of Littleton.

39 Section 2. The Resolution shall take effect upon its approval by the Littleton City
40 Council.
