26 27 28	Section 1: Chapter 6 of article 1 of the city code is hereby amended with the addition of the following sections:
29 30	1-6-21: PROCEEDINGS
31 32 33	The municipal court shall keep a verbatim record of the proceedings and evidence at trials by either electronic devices or stenographic means.
34 35	1-6-22: QUALIFICATION OF JUDGES
36 37 38	The municipal court judge and all substitute judges shall be admitted to, and licensed in, the practice of law in the State of Colorado.
39 40 41 42 43 44 45	Section 2: Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.
46 47 48 49	Section 3: Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.
