A RESOLUTION OF THE PLANNING BOARD OF THE **CITY OF** LITTLETON, COLORADO, RECOMMENDING CITY **AMENDING** CODE SECTIONS 10-3-2 AND 10-8-2 ALLOWING TATTOO PARLORS AND BODY ARTS STUDIOS IN THE COMMUNITY BUSINESS DISTRICT (B-2), GENERAL BUSINESS DISTRICT (B-3) AND CENTRAL AREA MULTIPLE USE DISTRICT (CA) SUBJECT CONDITIONAL USE APPROVAL AND AMENDED WITH ALL SIGNAGE TO COMPLY WITH SECTION 4-3-2-5 OF THE CODE.
