13	WHEREAS, Littleton Invests for Tomorrow ("LIFT") is a body corporate and
14	has been duly organized, established and authorized by the City to transact business and exercise
15	its powers as an urban renewal authority, all under and pursuant to the Colorado Urban Renewal
16	Law, Section 31-25-101, et seq., Colorado Revised Statutes (the "Act");
17	
18	WHEREAS, pursuant to Section 31-25-109 of the Act, LIFT has the power and
19	authority to issue or to incur notes, interim certificates or receipts, temporary bonds, certificates
20	of indebtedness, debentures, advances, or other obligations, including refunding obligations, for
21 22	the purpose of financing the activities and operations authorized to be undertaken by LIFT with respect to the adopted urban renewal plans as approved by the city and urban renewal projects
22 23	undertaken by LIFT under the Act;
24	undertaken by LIF I under me Act,
25	WHEREAS, the Act, Section 18, Article XIV of the Colorado Constitution
26	authorizes the City and LIFT to enter into cooperative agreements; and
27	autionzes the erty and En 1 to enter into cooperative agreements, and
28	WHEREAS, the city charter provides that the city council, by resolution, may
29	enter into contracts with other governmental bodies to furnish or receive governmental services,
30	to make or pay charges for such services, and to enter into cooperative or other joint activities
31	with other governmental bodies;
32	
33	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
34	THE CITY OF LITTLETON, COLORADO, THAT:
35	
36	Section 1. The City Council hereby approves the Cooperation and Loan
37	Agreement between the City of Littleton, Colorado and Littleton Invests for Tomorrow.
38	Section 2. The City Council hereby authorizes an initial advance of \$50,000 in
39	accordance with the terms and conditions described in Section 3.0 of the Cooperation and
40	Loan Agreement.
