## II. Consideration of Minutes for Previous Supervisory Committee Meetings

There were no meeting minutes to approve from the October Supervisory Committee meeting, since the October 2018 Supervisory Committee meeting was cancelled by the Committee. The Committee voted unanimously to cancel the October meeting via email vote on October 3, 2018, by reason of no Action Items in need of approval and due to the recent resignation of Englewood's City Manager, Eric Keck, on October 5, 2018.

### III. Action Item(s)

### Beichle Farm Property Lease 2018:

Blair Corning discussed one (1) of the five (5) farm lease agreements held by the South Platte Water Renewal Partners (SPWRP) facility, with the Committee. SPWRP staff recommends that the Committee approve, by motion, a 2-year farm lease agreement with Kent Beichle for 471 acres of dryland farm property located South of Bennett, Colorado.

The SPWRP facility owns five (5) farm properties, four (4) of which are utilized for the beneficial application of domestic wastewater biosolids generated by the SPWRP facility. Previously, SPWRP leased this 471 acre farm property, which is not used for beneficial application, near Bennett, Colorado to Clint A. Burnet, for a 5-year term which began in 2016.

Mr. Burnet recently terminated this lease of the 471 acre property prior to its term. Committee policy states that SPWRP can lease to existing and former lessees and Beichle was an appropriate lessee because of proximity and past interaction with the SPWRP. SPWRP staff recommends leasing this vacant property to Mr. Kent Beichle for two (2) years. This 2-year lease term would complete the Burnet lease term, maintain lease rates and continuity of leasing cycles with all other farm properties owned by SPWRP. This lease, and the other 4 leases, will expire at the end of 2020. Both cities' attorneys have reviewed and updated the 2-year farm lease agreement.

<u>ACTION TAKEN</u> – The Supervisory Committee considered a motion to approve the recommended 2-year farm lease agreement with Kent Beichle for 471 acres of dryland farm property located South of Bennett, Colorado. Maria D'Andrea moved, Mark Relph seconded, three ayes, zero nays. Motion approved. Keith Reester absent. SPWRP staff plans to present this lease agreement to the Englewood and Littleton City Councils for their consideration in January and February 2019.
