9 **AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF**
10 **LITTLETON, COLORADO, AS THE GOVERNING BODY OF**
11 **THE CITY OF LITTLETON, COLORADO SEWER UTILITY**
12 **ENTERPRISE, AMENDING THE 2018 BUDGET**

15 **WHEREAS**, the city council established the City of Littleton, Colorado, Sewer
16 Utility Enterprise (the “Enterprise”) by Ordinance Number 6, Series of 2004; and

17
18 **WHEREAS**, the city council, as the governing board of the Enterprise, has the
19 authority under said ordinance to establish the budget for the Enterprise; and

20
21 **WHEREAS**, Ordinance No. 42, Series of 2017 established the budgeted
22 expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise; and

24 **WHEREAS**, the city council has determined it is in the best interest of all
25 ratepayers to separate the cost of treatment versus the cost to operate, maintain and improve
26 through capital construction the systems necessary to collect and transport the discharge for
27 treatment; and

28 **WHEREAS**, the necessity of receiving and expending additional monies from the
29 Enterprise could not have been reasonably anticipated during the time of adoption of this budget
30 and appropriation of funds in accordance therewith;

33 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**
34 **THE CITY OF LITTLETON, COLORADO, THAT:**

36 **Section 1:** The budgeted expenditures for the City of Littleton, Colorado, Sewer
37 Utility Enterprise for the period January 1, 2018 to December 31, 2018 are hereby amended by
38 the following addition:

43 **Section 2:** The total budgeted expenditures for the City of Littleton, Colorado,
44 Sewer Utility Enterprise for the period January 1, 2018 to December 31, 2018 shall be amended
45 to \$21,012,560.

47 **Section 3:** Severability. If any part, section, subsection, sentence, clause or
48 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
49 validity of the remaining sections of this ordinance. The City Council hereby declares that it

1 would have passed this ordinance, including each part, section, subsection, sentence, clause or
2 phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences,
3 clauses or phrases may be declared invalid.

5 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in
6 conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the
7 repealer clauses of such ordinance nor revive any ordinance thereby.

10 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
11 of the City of Littleton on the 6th day of February, 2018, passed on first reading by a vote of 7
12 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
13 Municipal Courthouse and on the City of Littleton Website.

14 PUBLIC HEARING on the Ordinance to take place on the 20th day of February,
15 2018, in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado,
16 at the hour of 6:30 p.m., or as soon thereafter as it may be heard.
