23 24 25 26 27 28	WHEREAS, an Amendment to Declaration of Agreement Establishing Building Restrictions in Plum Valley, Douglas County, State of Colorado, was recorded in the Douglas County Clerk and Recorder's Office on August 10, 1960 in Book 133, Page 174, to remove all of the property in the Plum Valley Subdivision from the provisions of the Declaration, except lots 1 to 6 inclusive, lots 42 to 45 inclusive and lots 7 to 16 inclusive, leaving a total of twenty (20) lots remaining subject to the Declaration;
29 30 31 32 33 34 35	WHEREAS, the Declaration provides that all of its restrictions and covenants shall continue and be binding upon the owners of the lots in Plum Valley Subdivision until January 1, 1960, at which time said restrictions and covenants shall be automatically extended for successive periods of ten (10) years unless by vote of a majority of the then owners of the fee simple title to such lots agree to release, change or amend said restrictions and covenants in whole or in part;
