7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
8 LITTLETON, COLORADO, APPROVING A SECOND AMENDMENT TO
9 THE INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF
10 LITTLETON AND THE COLORADO DEPARTMENT OF
11 TRANSPORTATION FOR REIMBURSEMENT OF COSTS ASSOCIATED
12 WITH THE SANTA FE DRIVE AND MINERAL AVENUE
13 OPERATIONAL IMPROVEMENTS PROJECT

15 WHEREAS, the council may, by resolution, enter into contracts with other
16 government bodies to furnish or receive governmental services, to make or pay for charges for
17 such services and to enter into cooperative or joint activities with other government bodies; and
18

19 WHEREAS, the Littleton City Council approved an intergovernmental agreement
20 by and between the Colorado Department of Transportation and the City of Littleton for the Santa
21 Fe Drive and Mineral Avenue Operational Improvements Project on May 5, 2020 (the
22 “Agreement”), and amended on February 6, 2024 (“First Amendment”); and

24 WHEREAS, the parties now desire to further amend the Agreement to provide for
25 additional grant funding, as set forth in Exhibit “A.”

27 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
28 THE CITY OF LITTLETON, COLORADO, THAT:
29

30 Section 1. The Littleton City Council hereby approves the Second Amendment to
31 the Intergovernmental Agreement by and between the City of Littleton and the Colorado
32 Department of Transportation for reimbursement of costs associated with the Santa Fe Drive and
33 Mineral Avenue Operational Improvements Project, CDOT Project No. AQC M810-017 (23574),
34 in substantially the same form as Exhibit “A” and the Mayor is hereby authorized to execute such
35 amendment to the intergovernmental agreement.
