7 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,**
8 **COLORADO, APPROVING CONSTRUCTION CONTRACT BETWEEN THE CITY OF**
9 **LITTLETON AND E&M CONCRETE, LLC. FOR THE 2024 MISCELLANEOUS**
10 **CONCRETE PROJECT – CITY PROJECT NO. 24-05**

12 **WHEREAS** pursuant to Section 1-15-62 of the Littleton Municipal Code, City
13 Council approval is a condition precedent to the approval of an Agreement in which the total value
14 of the Agreement is over five hundred thousand dollars and 00/100 cents (\$500,000.00); and
15

16 **WHEREAS** the city issued an Invitation for Bids soliciting bids for the 2024
17 Miscellaneous Concrete Project – City Project No. 24-05; and
18

19 **WHEREAS** the contractor, E&M Concrete, LLC submitted a response to perform
20 the project and the city, after examination of the contractor’s submittal, has determined that the
21 contractor has the requisite background, pricing, bond, and expertise to provide the requested
22 work; and

24 **WHEREAS** city staff recommends acceptance of the contractor’s proposal for
25 work in accordance with the issued Invitations for Bids; and

27 **WHEREAS**, the city and E&M Concrete, LLC desire to enter into an Agreement,
28 in which E&M Concrete, LLC. will perform work in accordance with the Agreement in Exhibit
29 “A”.

31 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF**
32 **THE CITY OF LITTLETON, COLORADO, THAT:**

34 **Section 1.** The Littleton City Council hereby approves the Agreement by and
35 between the City of Littleton and E&M Concrete, LLC., for the 2024 Miscellaneous Concrete –
36 City Project No. 24-05, in substantially the same form attached hereto as Exhibit “A,” and
37 authorizes the city manager, or authorized designee, to execute the same on behalf of the City of
38 Littleton.

40 **Section 2.** The Resolution shall take effect upon its approval by the Littleton City
41 Council.
