7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
8 LITTLETON, COLORADO, AUTHORIZING AN
9 AMENDMENT TO AN AGREEMENT REGARDING DESIGN
10 AND CONSTRUCTION OF DRAINAGE AND FLOOD
11 CONTROL IMPROVEMENTS FOR JACKASS GULCH
12 NORTH OF MINERAL AVENUE AND SOUTH OF WEST
13 JAMISON WAY, BETWEEN THE CITY AND THE URBAN
14 DRAINAGE AND FLOOD CONTROL DISTRICT FOR
15 STREAM EROSION PROTECTION

17 WHEREAS, the Council may, by resolution, enter into contracts with other
18 governmental bodies to furnish or receive governmental services, to make or pay charges for such
19 services and to enter into cooperative or joint activities with other governmental bodies;
20

21 WHEREAS, the City of Littleton wishes to mitigate erosion impacts and stabilize the
22 stream north of Mineral Avenue and south of West Jamison Way;

24 WHEREAS, the City of Littleton desires to enter into an Amendment to Agreement
25 14-05.06C Regarding Design and Construction of Drainage and Flood Control Improvements for
26 Jackass Gulch, contributing funds for erosion mitigation and stream stabilization; and

28 WHEREAS, the City's share of the costs of the project, as set forth in the
29 Amendment to Agreement Regarding Design and Construction of Drainage and Flood Control
30 Improvements for Jackass Gulch, shall be a contribution of 50% of the actual project costs, plus
31 indirect costs;

33 NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF LITTLETON,

36 The Amendment to Agreement Regarding Design and Construction of Drainage and
37 Flood Control Improvements for Jackass Gulch at Long Avenue, City of Littleton Agreement No.
38 14-05.06C is hereby approved.
