A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, APPROVING A CONSTRUCTION CONTRACT BETWEEN THE CITY OF LITTLETON AND TAK BROADBAND, LLC FOR THE LITTLETON BOULEVARD FIBEROPTICS INSTALLATION FOR TRAFFIC OPERATIONS PROJECT - CITY PROJECT NO. 21-37

WHEREAS pursuant to Section 1-15-62(a) of the Littleton Municipal Code, City Council approval is a condition precedent to the approval of an Agreement in which the total value of the Agreement is over five hundred thousand dollars and 00/100 cents \$500,00.00); and

WHEREAS the City issued an Invitation for Bid soliciting bids for the Littleton Boulevard Fiberoptics Installation for Traffic Operations Project, City Project No. 21-37; and

WHEREAS the contractor, TAK Broadband, LLC submitted a response to perform the project and the city, after examination of the contractor's submittal, has determined that the contractor has the requisite background, pricing, bond, and expertise to provide the requested work; and

WHEREAS city staff recommends acceptance of the contractor's proposal for work in accordance with the issued Invitation for Bid; and

WHEREAS, the city and TAK Broadband, LLC desire to enter into an agreement in which TAK Broadband, LLC will perform work in accordance with the terms and conditions outlined in the agreement, in substantially the same form attached hereto as Exhibit “A”.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
THE CITY OF LITTLETON, COLORADO, THAT:**

Section 1. The Littleton City Council hereby approves the construction contract by and between the City of Littleton and TAK Broadband, LLC, for the Littleton Boulevard Fiberoptics Installation for Traffic Operations Project, City Project No. 21-37, in substantially the same form attached hereto as Exhibit “A,” and authorizes the Mayor, or authorized designee, to execute the same on behalf of the City of Littleton.

Section 2. The Resolution shall take effect upon its approval by the Littleton City Council.
