**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LITTLETON,
COLORADO, APPROVING AN INTERGOVERNMENTAL AGREEMENT
WITH ARAPAHOE COUNTY FOR FIBER SHARING MRO
(MAINTENANCE, REPAIR, AND OPERATION) FOR LITTLETON
BOULEVARD AND BROADWAY**

WHEREAS, Article XIV, Section 18(2)(a) of the Constitution of the State of Colorado, and Part 2, Article 1, Title 29, C.R.S., encourages and authorizes intergovernmental agreements; and

WHEREAS, Section 29-1-203, C.R.S., authorizes governments to cooperate and contract with one another to provide any function, service, or facility lawfully authorized to each; and

WHEREAS, the City constructed a fiber optic communications system within the City consisting of fiber optic cable and associated equipment installed along public and private property and rights-of-way (the "City Fiber Network"); and

WHEREAS, the City Fiber Network provides sufficient capacity for both current, proposed, and anticipated municipal fiber optic purposes and the City Fiber Network also provides additional capacity that can be made available to others, including community anchor institutes; and

WHEREAS, the City and Arapahoe County (the "County") desire to participate together in their capacities as governmental and political subdivisions in providing limited access via fiber sharing to portions of the City and County Fiber Networks for the purpose of enhancing communication systems used for public purposes; and

WHEREAS, the City additionally desires to use the County as a Disaster Recovery Site for Information Technology purposes; and

WHEREAS, the terms and conditions related to the fiber sharing and the Disaster Recovery Site are set forth in the attached intergovernmental agreement ("IGA"); and

WHEREAS, the City Council desires to approve the IGA, a copy of which is attached hereto as Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
THE CITY OF LITTLETON, COLORADO, THAT:**

Section 1. The City Council of the City of Littleton hereby: (a) approves the attached IGA (Exhibit A) and (b) authorizes the Mayor and City Clerk to execute the IGA in substantially the form attached hereto upon approval of the final form of the IGA by the City Attorney.

Section 2. This resolution shall take effect immediately upon its adoption by the City Council.
